Gentlemen—On January 21, 1969, J.C.C. Pages 111 and 112, your Honorable Body adopted a resolution vacating a portion of the east-west public alley in the block bounded by Scotten, Bangor, Warren, and the Edsel Ford Freeway, as requested in Petition 7044, and authorizing the relocation of a lateral sewer in accordance with a supplement to Petition 7044.

The Housing Commission has now acquired all of the land abutting the remainder of the said east-west public alley. They now request that the resolution adopted by your Honorable Body be rescinded.

B. Campau Farm, T.2.S., R.11.E., Detroit, Wayne County, Michigan, as recorded in Antwerp, Liber 9, Page 24, Plats, Wayne County Carey—9. records.

Be and the same is hereby vacated to become a part and parcel of the abutting property; and be it further

Resolved, That the Detroit Edison Company and the Michigan Bell Telephone Company are hereby directed to remove all their lines and poles from the vacated alley without expense to the City of Detroit within thirty days after receipt of a copy of this resolution; and be it further

Resolved, That the City Clerk is hereby directed to mail to the Detroit Edison Company and the Michigan Bell Telephone Company a certified copy of this resolution.
