Gentlemen Since 1967 Detroit Health Department has been operating a program known as ECHO in conjunction with the Michigan Department of Public Health which is an ongoing program, in order to continually evaluate the health statistics of the City of Detroit. On a number of occasions, information derived from this project has been shown to your Honorable Body.

Although we have a appropriation to partially offset the cost of this program in the 1972-73 budget, we are continually attempting to obtain outside funding for this purpose. The information which we are accumulating is proving to be of significant value to a number of agencies and one of these, the Michigan Hospital Service, has given the Health Department a grant of \$15,000 to offset some of the cost of this project.
