Gentlemen-In order to develop the Department of Public Works' Davison Yard at Davison and Cherrylawn, it will be necessary to vacate the streets and alleys in the area.

The privately-owned utility companies and the involved City Departments were contacted and have re-

plied as follows:

The Michigan Consolidated Gas Company has replied that they have 4 inch mains in Turner Avenue and Roselawn Avenue which may be abandoned. They have submitted as estimated cost to abandon these facilities of \$2,340.00;

The have also replied that there is a 12 inch main located in Greenlawn Avenue which will require an easement, proper provisions are included

in the vacating resolution;
2) Michigan Bell Telephone Company has replied that they have a major trunk conduit located east of the east property line of Cloverlawn Avenue. Proper provisions granting an easement are included in the vacating resolution;

3) Detroit Metro Water Department has replied that they have a 16 inch water main in Turner Avenue which will require a temporary easement until the line is relocated as a part of the Jeffries Freeway construction. Proper provisions granting the easement are included in the vacating resolution;

Public Lighting Commission has replied that it will be necessary to relocate two poles in the area. They have submitted an estimate of \$850.00

to perform the relocation.

5) Fire Department has replied that it will be necessary to retain a temporary easement for their hydrant located in Turner in order to avoid moving it twice; proper provisions granting said easement are included in the vacating resolution;
