Subject: Charges for Repair to Private Sewers - Request Special Assessment Rolls.

The City of Detroit Municipal Code, Chapter 56, Page 1037, Section 56-1-9, provides that uncollected charges for repairs to private sewers, performed by City forces, of any private drain or sewer will be levied as a special against the properties assessment concerned.

When the Water Department assumed the operation and maintenance of the Sewer System from the Department of Public Works in July 1964, we also accepted the responsibility for repairing any private drain or sewer which created an unsafe or unhealthful condition to the City as a whole.

On July 3, 1973, this Department was notified by Dr. William Clexton, Director of Public Health, to take whatever action necessary to alleviate
