Gratiot along the Block. These provisions have been approved by the Department of Transportation.

2. The erection of food booths along the above-listed lanes and cultural booths on the Block itself. The Health Department will monitor the preparation and distribution of food.

3. The supplying of water from the Fire and Water Departments through the auspices of the Recreation De-partment. All departments are aware of these needs. Provide adequate electrical outlets through a transformer provided by the Public Lighting Department and prepared by the Central Business Maintenance Division of the Environmental Protection Maintenance Department. Again these departments are aware of their responsibilities.

4. Lastly, we ask the Council's permission to allow the Ethnic Bicentennial Council to dispense pop, beer and wine from their own four booths during the course of the fair. We emphasize that no other booths except those four controlled by the Ethnic Bicentennial Council will be allowed to sell beverages. Also the Council leadership has taken great care to insure that these sales will be controlled. All the people dispensing the beverages will be unionized bartenders from the Hotel and Restuarant Employees, Cooks and Bartenders Union Local No. 24. Also the Council has received extensive insurance coverage and has contracted private police to augment the regular Detroit police assigned to the event as well as to guard the area at night.

Ethnicity has been one of the themes of the Detroit Bicentennial Commission since its inception in 1974. The Commission feels that Heritage Week in all its many aspects will be a most appropriate way by which the city's ethnic mosaic can be known and appreciated by a large number of Detroiters.
