Re: Correction to the Resolution Vacating Gibson Avenue from Canfield Avenue to Lysander Avenue and North and South Alley Easterly Thereof.

It recently came to our attention that the original vacating resolution for Gibson Avenue between Canfield and Lysander, Petition No. 5221, as recorded in the J.C.C., pages 2329-2330, dated October 23, 1956 was written in the J.C.C. ten incorrectly.

In our response to the petition by

the Board of Education to vacate Gibson Avenue and the north-south alley located east of Gibson, we indicated that we had no objection to the vacation of the alley but we asked that a sewer easement be re-tained for the full width of Gibson, since there was a 9 ft. 6 in. sewer and a 10 in, sewer located therein.

The letter to the City Council in response to Petition No. 5221 stated that a proper provision was incorporated into the vacating resolution protecting the City's interest in the sewer located in Gibson Avenue. However, in the vacating resolution, a sewer easement was erroneously re-tained for the alley instead of for Gibson Avenue.

Since Gibson Avenue was incorrectly vacated and a sewer easement is still needed for that portion of Gib-son Avenue, we recommend that the original vacating resolution be leted and replaced by the enclosed resolution.

Also enclosed is a copy of a letter from the Board of Education stating that they are agreeable to the change and to the proposed new resolution. The Board of Education was the original petitioner and still owns the property involved.
