WHEREAS, Titan Steel (Petition No. 6077) has petitioned this Council to establish a Plant Rehabilitation District in the area of 17287 Mt. Elliott, more particularly described in Exhibit A attached hereto; and

WHEREAS, The Petitioner is the owner of at least 75% of the state equalized value of the industrial property located within the proposed Plant Rehabilitation District; and

WHEREAS, On the 1st day of May, 1978 in the City Council Committee Room, 13th Floor, City-County Building, a public hearing was held on the question of the establishment of this Plant Rehabilitation District at which time the petitioner, any other owners of real property within the proposed district, and any other resident or taxpayer of the City of Detroit had an opportunity to be heard; and

WHEREAS, Written notice of this public hearing was given by certified mail to the owners of all real property within the proposed Plant Rehabilitation District;

NOW THEREFORE BE IT

RESOLVED, That it is hereby found and determined that the property comprising not less than 50% of the state equalized valuation of industrial property within the district is of solete; and be it further

RESOLVED, That the property referred to above and more particularly described in Exhibit A attached hereto is hereby established as a Plant Rehabilitation District for purposes of Act No. 198 of the Public Acts of 1974, as amended; and be it further

RESOLVED, that all that part of the North/South public alley, eighteen (18) feet wide, in the block bounded by KEELER, SORRENTO, FENKELL and WARD AVENUES, abutting the rear line of Lots 329 to 341, both inclusive, on the West of said alley, and Lots 449 to 461, both inclusive, on the East of said alley, in the COLLEGE CREST SUBDIVISION NO. 1 of part of the West ½ of the East ½ of the Southwest ¼ Section 17, Town 1 South, Range 11 East, city of Detroit, Wayne County, Michigan, as recorded in Liber 50, Page 13 of Plats, Wayne County Records.

Be and the same are hereby vacated as public alleys and are hereby converted into public easements of the full width of the alley, which easements shall be subject to the following covenants and agreements, uses, reservations and regulations, which shall be observed by the owners of the lots abutting on said alleys and by their heirs, executors, administrators and assigns, forever to wit:

FIRST, said owners hereby grant to and for the use of the public easements or right-of-ways over said vacated public alleys hereinabove described for the purposes of maintaining, installing, repairing, removing, or replacing public utilities such as water mains, sewers, gas lines or mains, telephone, electric light conduits or poles or things usually placed or installed in a public alley in the City of Detroit, with the right to ingress and

egress at any time to and over said easements for the purpose above set forth.

SECOND, said utility easements or right-of-ways in and over said vacated alleys hereinabove described shall be forever accessible to the maintenance and inspection forces of the utility companies, or those specifically authorized by them for the purpose of inspecting, installing, maintaining, repairing, removing, or replacing any sewer conduit, water main, gas line or main, telephone or light pole or any utility facility placed or installed in the utility easements or right-ofways. The utility companies shall have the right to cross or use the driveways and yards of the adjoining properties for ingress and egress at any time to and over said utility easements with any necessary equipment to perform the above mentioned tasks, with the understanding that the utility companies shall use due care in such crossing or use, and that any property damaged by the utility companies other than that specifically prohibited by this resolution shall be restored to a satisfactory condition.

THIRD, said owners for their heirs and assigns further agree that no buildings or structures of any nature whatsoever including but not limited to concrete slabs or driveways, retaining or partition walls (except necessary line fence) shall be built or placed upon said easements, nor any change of surface grade made, without prior approval by the Environmental Protection and Maintenance Department.

FOURTH, that if any any time in the future the owners of any lots abutting on said vacated alleys shall request the removal and/or relocation of any existing poles or other utilities in said easements, such owners, upon whose property the poles or other utilities are located shall pay all costs incidental to such removal and/or relocation, unless such charges are waived by the utility owners,

PROVIDED FURTHER, that if any utility located or to be located in said property shall break or be damaged as a result of any action on the part of the petitioner or assigns (by way of illustration but not limitation), such as storage of excessive weights of materials or construction not in accordance with Section 3, mentioned above, then in such event the petitioner or assigns shall be liable for all costs incidental to the repair of such broken or damaged utility and be it further

RESOLVED, That the City Clerk shall, within 30 days, record a certified copy of this resolution with the Wayne County Register of Deeds, and shall send a certified copy to the State Treasurer, and shall further transmit a copy of this resolution to the City Engineer, to the Law Department and to the Environmental Protection and Maintenance Department; and be it further

RESOLVED, That upon the receipt of a copy of the resolution, the Law Department shall notify the owners of the property abutting on such alleys or portions thereof and other necessary parties that the alleys or portions thereof have been vacated and converted into easements for utilities; and be it further

RESOLVED, That upon the receipt of a copy of the resolution, the City Engineer shall correct the official city maps and records; and be it further

RESOLVED, That upon the receipt of a copy of the resolution, the Environmental Protection and Maintenance Department shall adjust its garbage and refuse collection services accordingly.

WHEREAS, Pursuant to Act No. 198 of the Public Acts of 1974, as amended, this City Council has the authority to establish "Plant Rehabilitation Districts" within the boundaries of the City of Detroit; and

WHEREAS, Arco Alloys (Petition No. 6126) has petitioned this Council to establish a Plant Rehabilitation District in the area of 1891 Trombley and 1900 E. Milwaukee, more particularly described in Exhibit A attached hereto; and

WHEREAS, The Petitioner is the owner of at least 75% of the state equalized value of the industrial property located within the proposed Plant Rehabilitation District; and

WHEREAS, On the 17th day of May, 1978 in the City Council Committee Room, 13th Floor, City-County Building, a public hearing was held on the question of the establishment of this Plant Rehabilitation District at which time the petitioner, any other owners of real property within the proposed district, and any other resident or taxpayer of the City of Detroit had an opportunity to be heard; and

WHEREAS, Written notice of this public hearing was given by certified mail to the owners of all real property within the proposed Plant Rehabilita-

tion District;

NOW THEREFORE BE IT

RESOLVED, That it is hereby found and determined that the property comprising not less than 50% of the state equalized valuation of industrial property within the district is obsolete; and be it further

RESOLVED, That the property referred to above and more particularly described in Exhibit A attached hereto is hereby established as a Plant Rehabilitation District for purposes of Act No. 198 of the Public Acts of 1974, as amended; and be it further

RESOLVED, That the said Plant Rehabilitation District is hereby designated at City of Detroit Plant Rehabilitation District No. 67.
