In order to permit the sale and de-In order to the parcel of land development of the parcel of land lying velopment of Lafavette Avenue, west north of Lafayette Avenue, west of Mt. north of Edia, wood Park #2 renewal area, the Community and Economic Development Department has reduested that a portion of the utility easement in the location of vacated Leib Street be vacated, also the northerly 70 feet, approximately, of Lafayette Avenue be vacated and in. cluded in the land sale of Ren Center Indoor Tennis and Racquet Club.

The Department of Transportation reported that this part of Lafayette Avenue can be considered surplus due to the court decision which would not allow the construction of the widening of the street through the Beth El Temple Cemet.

The Water and Sewerage Department has asked that an easement be retained in the former Leib Street right of way for a sewer that must remain in service. The petition of the Indoor Tennis and Racquet Club No. 161 to construct a building over this sewer has been referred to that Department for their processing of agreement concerning that proposal.

The Water and Sewerage Department also has a water main in the Leib Street right of way which must be capped and abandoned prior to construction of any encroachment into the easement. Arrangements for this work are being made by the Community and Economic Development Department.
