## Department of Health April 16, 1979

Honorable City Council:

Re: Continuation of Program — Early Screening Health Services.

On several previous occasions your Honorable Body has authorized the Health Department to accept grants for the operation of the Early and Periodic Screening, Diagnosis and Treatment Program (EPSDT). We have now been advised by the Michigan Department of Public Health that the budget level of \$2,759,588 has been established for the operation of the program for the period December 1, 1978 to November 30, 1979. Prior to this time we have been operating at last year's budget level.

A major purpose of the EPSDT program is to create a public awareness of available public health care services to enable eligible individuals to attain the best condition of health possible. EPSDT screening carried out by health personnel, other than physicians, is accomplished by a series of tests, laboratory studies, a health history and physical inspection, and inassessments of physical growth, immunization status, and nutritional status. Any diseases or abnormalities detected by the initial or periodic screening will be treated by Title XIX eligible providers — physicians, clinics, hospitals, etc. — on a referral basis.

The grant provides for the hiring of personnel, the purchase of supplies and general miscellaneous expenses, the purchase and rental of equipment, and authorizes entering into arrangements with other agencies for screening who then become part of the overall program. In addition our department performs outreach including arrangements for appointments.

May we, therefore, be authorized by your Honorable Body to accept this grant in accordance with the foregoing

communication.

Deficits Re: Appropriation Surpluses.

The balances in the following appropriations are insufficient to cover our costs through June 30, 1979:

Appropriation No. - 0125 - Inspection and Safety

A Deficiency of \$36,000 in this appropriation is anticipated because reimbursable work has been less than the amount projected in our budget estimates.

Appropriation No. - 0128 - Construction and Maintenance

A Deficiency of \$964,000 is anticipated in this appropriation due to emergency overtime due to storm damage and the inability of the Public Lighting Department to devote time to reimbursable work and capital work at the rate projected in the 1978-79 budget.

We anticipate a surplus in the following appropriation:

Appropriation No. - 0131 - Heat and Power Production

A Surplus of \$1,000,000 is anticipated in this appropriation due to lower oil prices and consumption than projected in 1978-79 budget estimates.
