Re: Reimbursement of Moving/Telephone Expenses Sojourner Truth Homes.

The Detroit Housing Department's Modernization Program, Phase XII, has been funded by the Department of Housing and Urban Development for an extensive physical and environmental redesign of the Sojourner Truth Homes. The implementation of this program will dictate the need for the temporary relocation of some 57 tenants to other public housing units, either within Sojourner Truth or to other housing developments of the tenants' choice.

Relocation housing is being arranged for all 57 tenants and moving expenses for 37 of these tenants are to

be paid by the Wayne County Department of Social Services. The moving costs incurred by the remaining 20 tenants and telephone reinstallation costs of all 57 tenants become the responsibility of the Housing Department via the Modernization Program, which contains funding for this purpose.

A sampling of moving companies has determined that the average cost for a move from a 1-bedroom unit to be \$140.00 and that of a 3-bedroom unit \$260.00. It is proposed to allow these sums to the 20 tenants who are the responsibility of the Housing Department in addition to the \$30.00 cost for telephone reinstallation that is applicable to all 57 tenants requiring relocation and having telephone service. As none of the tenants requiring relocation occupy a 2-bedroom unit, no cost for this type of move has been established.

The Housing Department estimates that the total cost for reimbursement of moving/telephone reinstallation expenses for all 57 tenants will be \$5,830.00.

City Council approval is requested to authorize the Housing Department to reimburse tenants of Sojourner Truth Homes for moving and telephone reinstallation expenses necessitated by required relocation.

Provided, That no right in the public street shall be considered waived by this permission which is granted expressly on the condition that the fence and all obstructions in connection therewith shall be removed at the expense of the grantee at any time when so directed by the City Council; and further

Provided, If at any time in the future it becomes necessary to repair or replace the water mains or sewers or other utilities located or to be located in said street by the acceptance of this permission, the owners for themselves, their heirs and assigns, waive claims for any damages to the encroaching installations and agree to pay the costs incurred in their removal, if their removal becomes necessary and to re-
