In connection with the completion of the new Detroit Receiving Hospital Project, involving Detroit General Hospital and the Wayne State University Clinic Building, it is necessary that certain utility easements must be formally vacated (in vacated Willis Avenue and vacated Superior Avenue). The letter and resolution from the City Engineering Division of the Department of Public Works relative to the captioned petition is in response to the original petition to your Honorable Body from Wayne State University and Detroit General Hospital that was filed in 1974.

As your Honorable Body is aware, the ownership of the affected land is to be changed to reflect the current financial arrangements regarding the new Detroit Receiving Hospital and the Wayne State University Clinic Building. With respect to the Wayne State University Clinic Building portion of the property, the affected land is to be transferred from Wayne State University to Detroit Receiving Hospital and University Health Center, a Michigan nonprofit corporation. With respect to the portion on which the hospital is located, Detroit Receiving Hospital and University Health Center will have subleased the facility from the City of Detroit, and the City of Detroit has leased the facility from the City of Detroit Building Authority, the title holder to the affected land.

Consequently, in order to insure that all parties who will have an interest in the affected land have agreed with the requested vacations of the easements in vacated Willis and Superior Avenues, we are submitting the supplemental petition signed by Detroit Receiving Hospital and University Health Center, the City of Detroit, the City of Detroit Building Authority, and Wayne State University.
