Schools coupled with the relatively short amount of time prior to the desired start date of program effectively precludes the presentation of a contract, with the approval of all appropriate city departments, to City Council prior to the December 19, 1981, start date.

It is as a consequence of this particular dilemma that I am requesting City Council approval to allow the Police Department to conduct the training program prior to City Council approval of a contract with the Detroit Public Schools.

I assure you that a completed contract covering this program, together with all necessary documents, will be presented to City Council as soon as such a contract has been approved by School officials and has received the approval of all appropriate City departments.

In light of the fact that both the City of Detroit and the Detroit Public Schools exist to serve particular needs of the citizens of Detroit, I think it is important that the City and the Schools cooperate with each other whenever possible in an effort to help fulfill those needs. By conducting this supervisory training program for the Schools, the City will be assisting this effort.

I thank you for consideration on this matter.
