2. No contracts or purchase orders will be issued if, in my judgment, any Council member would want the contract or order held for formal acton by City Council.

Your Honorable Body approved the same procedure as outlined above for the City Council recess from August 6, 1981 through September 6, 1981 per your resolution of July 8, 1981.
