and shall be completed prior to the completion of site preparation and the beginning of major construction;

11. That the berming on the northern edge of the Emergency Room parking lot be extended along the eastern edge of the parking lot to the existing tree, and shall be completed prior to the completion of site preparation and the beginning of major construction;

12. That the hospital construct a fence of at least four feet in height on the hospital's side of the berm, said fence to run from Baldwin Avenue in a easterly direction paralleling the berm, across Seyburn Avenue, along the berm on the northern edge of the emergency parking lot, and then south until the berm ends at the existing tree. At that point it shall follow the property line until its meets the eastwest alley first north of and parallel to East Jefferson Avenue, as shown on the site plan. The detail of said fence shall be approved by City Planning Commission staff prior to installation or prior to the issuance of an occupancy permit;

13. That the emergency parking lot shall be depressed one and a half feet below existing grade at its northerly

14. That a hedge of evergreen trees shall be planted on top of the berm for its entire length with the exception of that strip which fronts on Lafayette

15. That additional heavy landscaping shall be planted on the berm that crosses Seyburn Avenue and around

the cooling towers;

16. That all berming shown on the site plan be at least three and a half feet above grade except where it crosses

Seyburn Avenue; and

17. That the hospital shall provide 5 recessed parking spaces as shown on the site plan on the west side of Baldwin perpendicular to the street, for use of residents and guests of 674 Baldwin.

## City Engineering Department May 22, 1984

Honorable City Council: Re: Petition No. 2678 - Detroit Macomb Hospital Corporation. Jennings-Blain-Memorial Hospital Project, East Jefferson at Seyburn.

The above petition requests the vacation and conversion to easement of certain streets and alleys in the area bounded by Sheridan, Seyburn, Jefferson and Lafayette.

The requested property changes were approved by the Community and Economic Development Department with the recommendation that sufficient land be dedicated for new street and alley outlets.

The petition was then referred to us for investigation and report. Our report accompanied by the petition is as fol-

lows:

The petitioner has reached agreement with the Detroit Edison Company, the Michigan Bell Telephone Company, the Michigan Consolidated Gas Company, the Detroit Water and Sewerage Department and the City Engineering Department to be responsible for all costs incurred in connection with the removal and/or relocation of existing utilities within the site.

The petitioner has also agreed to pave the newly dedicated streets and alleys and install a traffic island in Seyburn and Congress as approved by the Department of Transportation according to City Engineering Department specifications, and under City permit and inspection with all costs

borne by the petitioner.

The petitioner has also agreed with the Public Lighting Department to pay all costs, including inspection, disconnection and relocation fees, associated with the alteration of public lighting within the site. The petitioner further agrees to provide and install at their expense lighting standards approved by the Public Lighting Department and to maintain same.

A Warranty Deed has been received from the petitioner, deeding land to the City of Detroit for the new street and alley outlets. This deed will be forwarded to your Honorable Body for approval when the necessary land transactions with the Community and Economic Development Department are completed.

An Agreement and Grant of Easement for water mains and sewers has been received from the petitioner and has been approved by the Water and Sewerage Department. Provisions are contained in the attached resolution authorizing the Board of Water Commissioners to sign the agreement.

All other involved City departments reported that they will be unaffected by the vacation and conversion to easement of said streets and alleys or that they have reached satisfactory agreements with the petitioner regarding their installations therein.

An appropriate resolution is attached for consideration by your Honorable Body.

All that part of Baldwin Avenue, 66 feet wide, between Congress and Lafayette, abutting the easterly line of Lots 179 to 185 and the northerly 26.91 feet of Lot 186 all inclusive of Moses W. Field's Subdivision as recorded in Liber 4, Page 10, Plats, Wayne County records; and abutting the westerly line of Lots 208 to 212 inclusive of Wesson's Subdivision as recorded in Liber 16, Page 91, Plats, Wayne County records;

RESOLVED, that the Finance Department is hereby authorized and directed to issue Quit Claim deeds to the above described property and the Law Department is directed to prepare said deed.
