Re: Petition No. 2859, Sisters of Mercy Health Corporation Request for Vacation of Sewer Easement.

This is in response to Petition No. 2859 by Sisters of Mercy Health Corporation requesting vacation of the sewer easement retained in vacated Santa Maria Avenue, from Ardmore to Lesure Avenue. The retained easement also includes the alley between Ardmore and Stansbury Avenues, the alley between Stansbury and Lesure Avenues. and Stansbury Avenue, all from vacated Santa Maria Avenue to existing Santa Maria Avenue. These streets and alleys were vacated and the easement retained by Detroit Common Council (J.C.C. September 29, 1959, pages 1048 and 1049), and exist as shown on the attached sketch.

There are no City sewers or water mains located in the subject easement. There are sewer services crossing the easement at both above alleys, and a water service crossing the easement at Stansbury Avenue. These will remain under the ownership of Mt. Carmel Mercy Hospital, with attendant maintenance responsibility, extending south to the north line of existing Santa Maria Avenue.

It is therefore recommended that the petition for vacation of the sewer easement be granted in accordance with the attached resolution.
