Two buildings, a one-story masonry and a two story frame, were demolished by E. Wright Wrecking under City Contract D6592 in April, 1981. The above property at that time was owned by the State of Michigan. The City of Detroit took title on March 18, 1982. The City sold the vacant lot to Lonnie & Rosetema Thomas, January 26, 1983.

The City assessed the property for the costs of demolition in error.

Our department recommends the assessment issued against the property on Assessment Roll RUC 280 building demolition in the amount of \$6,368.00, be cancelled.

Re: Petition No. 3854, Uptown Land Development Corp., Requested outright vacation of portion of the east-west alley in the block bounded by Woodward, Second, Lothrop and Bethune.

The above petition requests the vacation of a portion of the east-west public alley, 20 feet wide, in the block bounded by Woodward, Second, Lothrop and Bethune Avenues to construct a 1300-car parking deck.

The requested vacation was approved by the Community and Economic Development Department. The petition was then forwarded to us for investigation and report. Our report is as follows:

The Detroit Water and Sewerage Department will abandon part of an existing 18-inch sewer in the east-west public alley, 20 feet wide, servicing the petitioner's property. This will require rerouting of that part of the sewer servicing the New Center Building and an alley catch basin. Plans have been approved by their Sewer Services Section. Sewer construction and bulkheading will be done by private contract under City permit, specifications and inspection with the entire cost being borne by the petitioner.

All other involved City departments and privately-owned utility companies reported they have no objections to the proposed vacation or they have reached satisfactory agreements with the petitioner regarding their installations therein.

An appropriate resolution is attached for consideration by your Honorable Body.
