In accordance with the 1986-87 budget adopted by Council, attached is the ordinance amending the Municipal Code to provide an increase to certain retirees receiving benefits under Title IX, Chapter V of the 1918 City of Detroit charter known as the "general old pension plan". In the memo to Council of February 10, 1986, Mr. John Marco, City Council Fiscal Analyst, identified 34 retirees under the General Fund, Library and Water fund of the "old pension plan" who average only \$3,361 in pension per year.

This amendment will provide for a flat monthly pension benefit of \$800.00 to each retirant. This rate will become effective July 1, 1986.
