Studies conducted by this department indicate that traffic signal control is no longer needed at the following locations:

1. American-Joy Rd. — Traffic studies conducted at this location indicates that traffic signal control is no longer needed. The signal has been on 24-hour flashing operation since March 27, 1985 without negative reaction from the public or compromising traffic safety.

2. Canfield-Moran — Traffic studies conducted at this location indicate traffic signal control is no longer needed. the signals have been placed on four-way flashing red since January 10, 1985 with a four-way "Stop" sign installed April 1, 1985. There have been no reported traffic problems.

Lemay-E. Warren — This location was signalized in September of 1952 specifically for the safe crossing of Warren by school children attending St. Margaret Mary School. Since the school is now closed and the signals have been on flashing operation since August 22, 1985, signal operation is no longer needed at this location.
