Re: Jefferson-Conner Industrial Revitalization Project Addendum — Alley to Vacation portion of east-west public alley in the block bounded by Glover, Hillger, Edlie and Jefferson.

To revitalize the Jefferson-Conner Industrial Area, a resolution vacating necessary public streets and alleys was adopted by your Honorable Body on May 27, 1988.

However, a portion of public alley was omitted by error from the vacating resolution. It is necessary to addend the vacating resolution to include a portion of the east-west public alley, 20 feet wide, in the block bounded by Glover, Hillger, Edlie and Jefferson Avenues.

The adoption of the attached resolution (as an addendum) is recommended.

Also, a waiver or reconsideration is respectfully requested to proceed with land consolidation for a major industrial development project in Detroit.

Whereas, In order to revitalize the Jefferson-Conner Industrial Area, it is necessary to addend the resolution adopted on May 27, 1988 vacating the project area public streets and alleys; therefore be it

Resolved, All that part of the east-west public alley, 20 feet wide, in the block bounded by Glover, Hillger, Edlie and Jefferson Avenues lying southerly of and abutting the south line of the east 21.00 feet of Lot 1, and Lots 2 to 4; also lying northerly of and abutting the

north line of Lot 5 of "Hutton, Tigchon and Nall Subdivision", part of Private Claims 641, 633, 687 and 392, Village of Fairview, City of Detroit, Wayne County, Michigan as recorded in Liber 24, Page 18, Plats, Wayne County Records;

Be and the same is hereby vacated as a public alley to become part and parcel of the abutting property; and

Provided, That a certified copy of this resolution shall be recorded with the Wayne County Register of Deeds. The Community and Economic Development Department shall pay all incidental recording costs.

Honorable City Council:

Re: Collections Management at the Detroit Historical Museum.

The Historical Department of the City of Detroit has perhaps the largest collection of artifacts devoted to the history of any U.S. city. This collection was assembled without a coherent plan or policy and often stored in a wretched manner. The Department feels this three dimensional memory of Detroit and southeast Michigan, so trustingly donated in expectation of preservation by thousands of Detroiters and Michiganders, deserves better. Physically the Department is working to meet the public trust this collection represents by making the renovation of storage areas,
