Honorable City Council:

Re: Jefferson-Conner Industrial Revitalization Project Addendum — Alleys to Vacation Two remaining north-south public alleys east of Hart between Kercheval and Charlevoix.

To revitalize the Jefferson-Conner Industrial Area resolutions vacating necessary public streets and alleys were adopted by your Honorable Body. (May 27, 1988, J.C.C. pp. 1333-39; June 8, 1988, J.C.C. p. 1471; October 12, 1988, J.C.C. p. 2557.)

However, two remaining public alleys (originally thought to be private alleys) were omitted from the referenced vacating resolutions. It is necessary to addend the (May 27, 1988) vacating resolution to include the two remaining north-south public alleys (variable width) east of Hart Avenue between Kercheval and Charlevoix Avenues.

The adoption of the attached resolution (as an addendum) is recommended.

Also, a waiver of reconsideration is requested to proceed with land consolidation for a major industrial development project in Detroit.

Whereas, In order to revitalize the Jefferson-Conner Industrial Area, it is necessary to addend the resolution adopted on May 27, 1988 vacating the project area public streets and alleys; therefore be it

Resolved, All of the remaining part of the north-south public alley (variable width to 8.95 feet; as widened on October 14, 1913, J.C.C. p. 1463) east of Hart Avenue between Kercheval Avenue and E. Vernor Highway lying easterly of and abutting the east line of Lots 113 to 125 of "Hart Farm Subdivision," Block 2, of part of Private Claims 641, 638 and 687, Village of Fairview and Township of Grosse Pointe, City of Detroit, Wayne County, Michigan as recorded in Liber 24, Page 53, Plats, Wayne County Records; also

All of the north-south public alley (variable width to 8.97 feet; as widened on October 14, 1913, J.C.C. p. 1463) east of Hart Avenue between E. Vernor Highway and Charlevoix Avenue lying easterly of and abutting the east line of Lots 121 to 150 of "Hart Farm Subdivision," Block 3, of part of Private Claims 641, 638 and 687, Village of Fairview and Township of Grosse Pointe, City of Detroit, Wayne County Michigan as recorded in Liber 24, Page 53, Plats, Wayne County Records;

Be and the same are hereby vacated as public alleys to become a part and parcel of the abutting property; and

Provided, That a certified copy of this resolution shall be recorded with the Wayne County Register of Deeds.
