Re: Community and Economic Development Department — Larned-Bates Rehabilitation Project (a/k/a One Detroit Center). Vacation of Streets and Alley in the area bounded by Woodward, Randolph, Larned, and Congress.

To develop properties in Larned-Bates Rehabilitation Project it is necessary to vacate Bates Street (variable width; between Congress and Larned), a portion (7.4 feet by 160.00 feet) of Larned Street (60 feet wide; east of Woodward), 2 portions (both 7.4 feet by 160.00 feet) of Congress Street (60 feet wide; one portion east of Woodward, one portion west of Randolph); also the north-south public alley, 20 feet wide, in the block bounded by Woodward, Bates, Larned, and Congress.

The public street(s) and alley closings were approved by the Department of Transportation; subject to the execution of an agreement and grant of easement(s) for ground-level pedestrian walks), and certain City-owned utilities traffic signal equipment, hydrants, lights).

There is an existing 13.5 feet diameter

public sewer in Bates Street. To protect the existing public sewer and reserve access rights, it is necessary to authorize the Water and Sewerage Department to execute an agreement and grant of easement (for and on behalf of the City of Detroit) to allow for construction over the Bates sewer.

Further, the City owns all public rightsof-way in the "Governor and Judges" in fee. Therefore, the Finance Director must execute quit-claim deeds to transfer vacated public rights-of-way.

Satisfactory arrangements have been made with all City departments and privately-owned utility companies.

Re: One Detroit Center Project, Request to Terminate an Agreement between the City and Owners of the Greyhound Bus Terminal.

Hines Detroit Corporation, the current owner of the Greyhound Bus Terminal, has requested termination of an agreement executed in 1957 between the City and the owners of the Greyhound Bus Terminal (No. E-294829 as recorded on November 7, 1957 in Liber 13543, Page 517 through 530, Wayne County, Michigan Records). This agreement created building set-back areas (near the Bates and Congress Street frontages of the Greyhound building) in order to permit maintenance of a tax-cab stand, street widening, overhangs and pedestrian

sidewalk alterations. The requested termination would be effective upon demolition of the Greyhound Terminal.

When the Greyhound Terminal is demolished, the referenced agreement will be inapplicable and will be an unnecessary encumbrance against the property.

Therefore, it is necessary to authorize the Finance Director to execute (for and on behalf of the City) a document to terminate the referenced agreement between the City and Greyhound, effective upon demolition of the Greyhound Terminal.

Recitals

A. Hines owns a parcel of property located in downtown Detroit, Michigan, more particularly described on Exhibit A attached hereto (the "Property"), on which is currently located the Greyhound Bus Terminal (the "Terminal").

B. Hines' predecessor in interest, The Greyhound Corporation, executed an Agreement with the City of Detroit dated October 14, 1957, which Agreement was recorded in Liber 13543, page 517, Wayne County Records, Michigan ("Agreement"), was respect to the construction and maintenance of the Terminal and the widening of Bates Street.

C. Hines intends to demolish the Terminal, and to construct upon it, and certain adjacent land, a mixed-use office development (the "Project"), which will revitalize the surrounding area.
