Honorable City Council:

Re: Petition No. 1418, Community and Economic Development Department, Mid-City Rehabilitation Project, VA Medical Center (Hospital) Site Street and Alley Vacatlons within the area bounded by John R., Brush, Canfield, and Hancock; also land dedication for John R. widening.

To develop properties in Mid-City Rehabilitation Project it is necessary to vacate public streets and alleys in the area bounded by John R. and Brush Streets, Canfield and Hancock Avenues; also it is necessary to set-aside City-owned land for the widening of John R. Street (from 60 to 84 feet wide).

The public street and alley closings were approved by the Department of Transportation.

A portion of the "Springwells Raw Water Tunnel" is located beneath Forest

Avenue, 70 feet wide, between John R. and Brush Streets. The Water and Sewerage Department (DWSD) has executed a "Construction Approval Agreement" and granted an "Easement Encroachment Permit" (as per Law Department letter dated January 26, 1990) with the United States Department of Veterans Affairs (VA) to construct over and in close proximity to the "Springwells Raw Water Tunnel" for the purpose of construction of a Veterans Administration Medical Center Hospital. Provisions protecting the "Springwells Raw Water Tunnel" are contained within the documents executed by DWSD and VA.

Satisfactory arrangements have been made with all other City departments and privately-owned utility companies.

An appropriate resolution is attached for consideration by your Honorable Body.

Resolved, Pursuant to the Court ruling in Center Line v Michigan Bell Telephone Co. 26 Mich. App 659 (1970), aff. 387 Mich. 260 (1972) the Community and Economic Development Department is hereby authorized to process billings from utility companies and others for the relocation of their equipment in connection with this urban renewal project. However, prior to the processing of bills, the Community and Economic Development Department shall consult with the Law Department to determine which utility removal and/or relocation costs incidental to this urban renewal project are obligatory under current Michigan court rulings; and further

Provided, That the City Clerk shall within 30 days record a certified copy of this resolution with the Wayne County Register of Deeds; and be it further

Re: Federal-Aid Urban Highway Program, Resurfacing of Outer Drive, Chandler Park Drive to Mack Avenue, MDOT Agreement No. 91-1264.

We are transmitting herewith, for your consideration, a proposed MDOT Agreement No. 91-1264 between the Michigan Department of Transportation, the County of Wayne, and the City of Detroit which provides for the following project:

"The resurfacing of existing Outer Drive from Chandler Park Drive to Mack

Avenue; the construction of curb and gutter, drainage structures and sidewalks as may be required; and all together with necessary related work".

The total cost of this project is estimated to be \$1,068,300 with the following participation:

Federal-Air	\$801,225
Wayne County	\$267,075
City of Detroit	\$-0-

Although the City is not participating in the project cost, it is a signatory since the project is within its jurisdiction and it is involved in the enactment, and enforcement of ordinances/regulations to prohibit parking. If required, the City will be responsible, at its own expense, for the removal and relocation of municipal utilities located within its roadway right-of-way.

We therefore recommend adoption of the attached resolution, with a waiver of reconsideration which approves the agreement and authorizes the Street Administrator to execute it in behalf of the City of Detroit.
