Re: Petition No. 3332. Community and Economic Development Department Medical Center Rehabilitation Project No. 4 Street and Alley Vacations, Dedications, and Public Walk (rights-of-way) in the area bounded by Brush, St. Antoine, E. Warren and Frederick.

To develop properties in Medical Center Rehabilitation Project No. 4 it is necessary to vacate public streets and alleys in the area bounded by Brush and St. Antoine Streets, E. Warren and Frederick Avenues; also it is necessary to set-aside City-owned land for the widening of Brush Street, and (the "as built" alignment) of E. Warren Avenue; also to retain certain areas for public walk (rights-of-way) within the proposed development.

The public street and alley closings were approved by the Department of Transportation.

Provisions protecting underground utility installations (in parts of Beaubien, Farnsworth, and the necessary alleys) are part of the resolution.

Satisfactory arrangements have been made with all City departments and privately-owned utility companies.

An appropriate resolution is attached for consideration by your Honorable Body.
