Re: Petition No. 2757 Vacation of the sewer easement retained during the vacation of relocated Farnsworth (Petition No. 1909) and vacation of the sewer easement retained during the vacation of the North-South alley, first east of Russell between Farnsworth and Theodore (JCC, March 16, 1971, P. 548-553)

Petition No. 2757 is from Thorn Apple Valley requesting the vacation of the sewer easement retained during the vacation of relocated Farnsworth (Petition No. 1909) and vacation of the sewer easement retained during the vacation of the North-South alley, first alley east of Russell between Farnsworth and Theodore (JCC, March 16, 1971, P. 548-553).

In order to vacate the above said sewer easement, the petitioner shall relocate the existing City sewer located

therein. All costs for the sewer relocation shall be borne by the petitioner.

We recommend that the petition be granted in accordance with the attached resolution.

Resolved, that the existing sewer easement located north of Theodore Avenue between Russell and Riopelle Avenue retained by City Council resolution of Petition No. 1909 for the vacation of relocated Farnsworth Avenue, the easement is described as an 18.78 foot wide/east-west alley in the block bound by Russell, Riopelle, Theodore and Farnsworth as platted in "Betzing's Subdivision" and recorded in Liber 10, Page 86, Plats, Wayne County Records; and as platted in "Freud and Schulte's Subdivision" and recorded in Liber 7, page 17, Plats, Wayne County Records; be and the same is hereby vacated as a sewer easement with any sewer located therein reverting to the Petitioner and no longer being City of Detroit's responsibility; and be it further

Resolved, that the existing sewer easement located east of Russell Avenue and Theodore Avenue retained by the City Council resolution of March 6, 1971, page 552, for the vacation of the north-south public alley, 16.60 feet wide, in the block bound by Russell, Riopelle, Theodore and Farnsworth as platted in "Betzing's Subdivision" as recorded in Liber 10, Page 86, Plats, Wayne County Records, be and the same is hereby vacated as a sewer easement with any sewer located therein reverting to the Petitioner and no longer being City of Detroit's responsibility; and be it further

Provided, that the Petition (No. 2757) shall relocate that portion of the existing lateral sewer located in the above said easements as required by the Detroit Water and Sewerage Department prior to the construction of the proposed building; and further

Provided, that the portion of the existing lateral sewer not relocated due to construction shall remain as City property and part of the City system; and further

Provided, that the Detroit Water and Sewerage Department be and is hereby authorized to review the drawings for the relocated lateral sewer and to issue a permit for the construction of the lateral sewer; and further

Provided, that the plans for the lateral sewer shall be prepared by a registered Engineer; and further

Provided, that the entire work is to be performed in accordance with plans and



specifications approved by the Detroit Water and Sewerage Department, and constructed subject to the inspection and approval of the Detroit Water and Sewerage Department; and further

Provided, that the entire cost of the lateral sewer construction, including inspection, survey and engineering shall be borne by the Petitioner; and further

Provided, that the Petitioner shall deposit with the Detroit Water and Sewerage Department, in advance of engineering, inspection and survey, such amounts as that Department deems necessary to cover the costs of these services; and further

Provided, that the Petitioner shall grant to the City a satisfactory easement for the relocated lateral sewer and also for that portion of the existing lateral sewer which is to remain City property prior to construction; and further

Provided, that the Board of Water Commissioners shall accept and execute the easement grant on behalf of the City; and further

Provided, that upon satisfactory completion of the sewer construction, the sewer shall be City property and become part of the City system.
