Honorable City Council:

Re: Petition No. 2708, Boulevard Temple Retirement Home, Requesting permission to fence a portion (west side) of Rosa Parks between Lothrop and West Grand Blvd. to expand a playground seating area.

Petition No. 2708 of "Boulevard Temple Retirement Home" requests permission to encroach into the west side of Rosa Parks Boulevard, 120 feet wide, between Lothrop Avenue and West Grand Boulevard for the purpose of expanding a playground-seating area.

In a letter (dated March 2, 1993) from the City Planning Commission (CPC) to the Department of Public Works (DPW) request was made for a traffic study. The

CPC report states:

"Our office has been assisting the Boulevard Temple Retirement Home...in the expansion of their facility to accommodate outdoor seating for residents, and play area for the day care center on site. In the process, we were informed of Boulevard Temple's concern about traffic accidents occuring on their property, specifically:

 Traffic accidents at the corner of Rosa Parks and W. Grand Blvd., in which automobiles jump the curb and hit the

corner of the building;

2. Automobiles speeding south of Rosa Parks (particularly on Friday and Saturday nights), and the danger of their not making the westbound turn onto Lothrop. When the expansion occurs there will be increased danger of automobiles crashing into the playground area...'

Detroit Code Sec. 55-2-8 assigns the investigation of petitions relating to streets and traffic problems to DPW-Traffic Engineering. On July 6, 1993 the City Engineering Department received a
