Re: Grant and Acceptance of a 10' Easement for Public Utilities Adjacent to Virginia Park Estates Subdivision.

The Planning & Development Department respectfully requests City Council authorization to enter into a Utility Easement Agreement that would create a ten foot wide easement for public utilities to service the Virginia Park Estates Subdivision and ten homes on Pallister Avenue adjacent to the subdivison.

**Description of New Easement** 

A legal description for the easement is provided in the resolution. The center line of the ten foot wide easement will be located parallel to and 120 feet northerly of the north line of Pallister Avenue and will extend approximately 900 feet easterly from the east line of Rosa Parks Boulevard.

The easement will accommodate a lateral sewer connector line, a cable televsiion line, and Detroit Edison electrical service lines for new homes in the southerly portion of the Virginia Park and for the ten adjacent homes on Pallister Avenue.

The easement is requested by the Detroit Water & Sewerage Department and Virginia Park Estates project engineers in order to adequately and costeffectively meet utility requirements for the new subdivision.

**Utility Easement Agreement** 

The Law Department, in consultation with the Public Works Department and agencies providing utilities, including the Water and Sewerage Department, the Public Lighting Department, and public utility companies, has prepared a Utility Easement Agreement for the creation of the easement. The properties subject to the easement are owned by eleven owners along Pallister Avenue. The City of Detroit owns property at the intersection of Pallister Avenue and Rosa Parks Boulevard that will be subject to the easement. In addition, the ten existing homes along Pallister will be subject to the easement. All ten of the Pallister Avenue property owners have agreed to execute the Utility Easement Agreement; execution by the City is required to give effect to the Utility Easement Agreement. Conclusion

The Planning & Development Department respectfully requests your Honorable Body authorize the Planning Director to execute the Utility Easement Agreement under which the City would grant and receive a reciprocal easement for public utilities adjacent to and for the benefit of the Virginia Park Estates Subdivision. An appropriate resolution is attached for your consideration.
