Honorable City Council:

Re: Petition No. 1972 McDonalds Corporation, et al Alley to Easement north-south public alley in the block bounded by Woodward, Bauman, W. 7 Mile, and Larchwood.

Petition No. 1972 of "McDonald's Corporation, et al" requests the conversion of the north-south public alley, 15 feet wide, in the block bounded by Woodward and Bauman Avenues, W. Seven Mile Road, and Larchwood Avenue into a private easement for public utilities.

The requested conversion was approved by the Planning and Development Department, Solid Waste Division - DPW, and Traffic Engineering Division - DPW. The petition was referred to the City Engineering Division - DPW for investigation (utility review) and report. This is our report:

The petitioner(s) plan to remove the paved alley return entrances (into W. Seven Mile Road and Larchwood Avenue). The petitioner(s) shall pay all incidental removal costs whenever discontinuance of use makes removal necessary.

City departments and privately owned utility companies have reported no objections to the conversion of public rights-of-way into a private easement for public utilities. Provisions protecting utility installations are part of the resolution.

I am recommending adoption of the attached resolution.

RESOLVED, All of the north-south public alley, 15 feet wide, in the block bounded by Woodward and Bauman Avenues, W. Seven Mile Road, and Larchwood Avenue lying westerly of and abutting the west line of Lot 47; also lying easterly of and abutting the east line of Lots 48 thru 51 of "Ivanhoe Addition Subdivision of Lot 2 of Peter Dixon's Subdivision of East Half of Southwest Quarter of Section 2, Town I South, Range 11 East, Greenfield ['Township]," City of Detroit, Wayne County, Michigan as recorded in Liber 18, Page 70, Plats, Wayne County Records;

Be and the same is hereby vacated as a public alley and is hereby converted into a private easement for public utilities of the full width of the alley, which easement shall be subject to the following covenants and agreements, uses, reservations and regulations, which shall be observed by the owners of the lots abutting on said alley and by their heirs, executors, administrators and assigns, forever to wit:

FIRST, said owners hereby grant to and for the use of the public an easement or right-of-way over said vacated public alley herein above described for the purposes of maintaining, installing, repairing, removing, or replacing public utilities such as water mains, sewers, gas lines or mains, telephone, electric light conduits or poles or things usually placed or installed in a public alley in the City of Detroit, with the right to ingress and egress at any time to and over said easement for the purpose above set forth,

SECOND, said utility easement or rightof-way in and over said vacated alley herein above described shall be forever accessible to the maintenance and inspection forces of the utility companies, or those specifically authorized by them, for the purpose of inspecting, installing, maintaining, repairing, removing, or replacing any sewer, conduit, water main, gas line or main, telephone or light pole or any utility facility placed or installed in the utility easement or right-of-way. The utility companies shall have the right to cross or use the driveways and yards of the adjoining properties for ingress and egress at any time to and over said utility easement with any necessary equipment to perform the above mentioned tasks, with the understanding that the utility companies shall use due care in such crossing or use, and that any property damaged by the utility companies, other than that specifically prohibited by this resolution, shall be restored to a satisfactory condition,

THIRD, said owners for their heirs and assigns further agree that no buildings or structures of any nature whatsoever including, but not limited to, retaining or partition walls, (excepting therefrom the appurtenances shown on the plan by "Lautzenheiser Associates Architects" 620 S. Dorchester, Royal Oak, MI 48067; phone: 810-399-2216; fax: 810-399-2774; L.A.A. #9601; drawing title: "McDonald's -Detroit Region, Street Address: Woodward and 7 Mile, City - Detroit, State- Michigan, County - Wayne, Site Location Code No. 021-1416; sheet No. C-1; date drawn: 2/8/96; Revision 1, date 2/12/96, entitled: 'Added public alley to be vacated'; Revision 2, date 2/21/96, entitled: 'Moved building forward of alley'; said installations shall be subject to the review and approval of the Fire Marshal and Buildings and Safety Engineering Department, if necessary) shall be built or placed upon said easement, nor change of surface grade made, without prior approval of the City Engineering Division - DPW,

FOURTH, that if the owners of any lots abutting on said vacated alley shall request the removal and/or relocation of any existing poles or other utilities in said easement, such owners, shall pay all costs incidental to such removal and/or relocation, unless such charges are

waived by the utility owners, FIFTH, that if any utility located in said property shall break or be damaged as a result of any action on the part of said result of any action on the part of said owners or assigns (by way of illustration owners or assigns of materials or conexcessive weights of materials or assigns shall be liable for all owners or assigns shall be liable for all owners incidental to the repair of such brocken or damaged utility; and further ken or damaged utility; and further

The Board of Directors of the Economic Development Corporation met on September 16, 1996 and adopted a Resolution of Inducement for the Mexican Industries Project. A copy of that Resolution with the Project Area and Project District Area (Exhibit "A") is attached.

In accordance with Section 4(2) and 4(3) of Public Act No. 338 of 1974, as amended, I hereby appoint the following individuals to the Board of Directors of the Economic Development Corporation of the City of Detroit as community representatives of the Mexican Industries Project.

Section 4(2) of Public Act 338 directs that for each project undertaken by the Economic Development Corporation of the City of Detroit, two additional members shall be appointed to serve on the Board of Directors.

In regards to their duties, the Act states that they "shall serve only in respect to that project and shall be representative of

neighborhood residents and business interests likely to be affected by the project and who shall cease to serve when the project for which they are appointed is either abandoned, or if undertaken, is completed in accordance with the project plan."

The appointees are qualified to fulfill the responsibilities associated with the positions and were selected on the basis of their demonstrated interest and their willingness to serve. Therefore, your approval of these appointments is requested.

In accordance with Section 12(1) of Act 338, your approval of the Mexican Industries Project Area and Project District Area is also requested.
