Honorable City Council:

Re: Petition No. 1911, Barrick Cold Warehousing, Storage & Location: 1921 E. Ferry, Petition No. 1847 Schlafer Iron and Steel, Location: 1950 Medbury, Street and Alley Vacations in the area generally bounded by the Grand Trunk Railroad, St. Aubin, E. Ferry and Harper.

Petition No. 1911 of "Barrick Cold Storage & Warehousing, Inc." together with Petition No. 1847 of "Schlafer Iron & Steel Company" requests the conversion of certain public streets and alleys in the area generally bounded by the Grand Trunk Railroad, St. Aubin, E. Ferry and Harper Avenues into private easement(s) for public utilities. Additionally, "Schlafer Iron & Steel Company" requests the outright vacation of one part of Roby Street, 50 feet wide, between E. Ferry and Medbury Avenues to install and maintain a permanent metal shredder system. City Council approved the sale of city owned property (about 2.06 acres) to "Schlafer Iron & Steel" on June 26, 1996 (J.C.C. page 1386).

The petitions were referred to the City Engineering Division - DPW by the Planning and Development Department for investigation (utility clearances) and report. This is our report:

Solid Waste Division —DPW and Traffic Engineering Division — DPW approved the public street and alley closings.

If it becomes necessary to remove the street and alley return entrances (into E. Ferry, Harper and/or St. Aubin Avenues), "Barrick Cold Storage" and/or "Schlafer Iron & Steel", the abutting owners, will pay all incidental removal costs.

Ameritech/Michigan Bell Telephone Company, Comcast Cablevision, Detroit Edison Company, Michigan Consolidated Gas Company (MCG), Water and Sewerage Department (DWSD), and Public Lighting Department reported facilities in the area generally bounded by the Grand Trunk Railroad, St. Aubin, E. Ferry and Harper Avenues.

The petitioner(s) made arrangements with MCG and DWSD to cut and cap gas and water mains within the development

City departments and privately owned utility companies reported no objections to the conversion of public rights-of-way into a private easement for public utilities. Provisions protecting utility installations are part of the resolution.

I am recommending adoption of the attached resolution.

Provided, That before any construction shall be permitted within the vacated (outright) part of public street, mentioned above, the petitioner shall apply to the and Safety Engineering Buildings Department for a building permit. Simultaneously, the petitioner shall submit said building plans to the Water and Sewerage Department (DWSD) for review and approval. The buliding plans shall include the following engineering details as required by DWSD:

Schlafer Iron & Steel", the abutting owners, and/or their contractors shall cut and cap the existing 8 inches diameter water main in Roby Street between E. Ferry and Medbury Avenues; also the existing 8-inches diameter water main in Medbury Avenue between Roby Street and St. Aubin Avenue; also

All costs related to the cut-cap of abandoned water main(s), including inspection and permits, shall be borne by "Schlafer Iron and Steel" at no cost to DWSD; and be it further

First, said owners hereby grant to and for the use of the public an easement or the use of the public an easement or right-of-way over said vacated public streets and alleys herein above described for the purposes of maintaining, installing, or replacing repairing, removing, or replacing public utilities such as water mains, sewers, gas lines or mains, telephone, electric light conduits or poles or things usually placed or installed in a public street or alley in the City of Detroit, with the right to ingress and egress at any time to and over said easement for the purpose above set forth,

Second, said utility easement or rightof-way in and over said vacated streets and alleys herein above described shall be forever accessible to the maintenance and inspection forces of the utility companies, or those specifically authorized by them, for the purpose of inspecting, installing, maintaining, repairing, removing, or replacing any sewer, conduit, water main, gas line or main, telephone or light pole or any utility facility placed or installed in the utility easement or right-ofway. The utility companies shall have the right to cross or use the driveways and yards of the adjoining properties for ingress and egress at any time to and over said utility easement with any necessary equipment to perform the above mentioned tasks, with the understanding that the utility companies shall use due care in such crossing or use, and that any property damaged by the utility companies, other than that specifically prohibited by this resolution, shall be restored to a satisfactory condition,

Third, said owners for their heirs and assigns further agree that no buildings or structures of any nature whatsoever including, but not limited to, concrete slabs or driveways, retaining or partition walls, (except necessary line fence; said fence and gate installations shall be subject to the review and approval of the Fire Marshal and Buildings and Safety Engineering Department, if necessary) shall be built or placed upon said easement, nor change of surface grade made, without prior approval of the City Engineering Division — DPW,

Fourth, that if the owners of any lots abutting on said vacated streets and alleys shall request the removal and/or relocation of any existing poles or other utilities in said easement, such owners, shall pay all costs incidental to such removal and/or relocation, unless such charges are waived by the utility owners. Fifth, that if any utility located in said

property shall break or be damaged as a property any action on the part of said owners or assigns (by way of illustration but not limitation) such as storage of excessive weights of materials or construction not in accordance with Section 3, mentioned above, then in such event said owners or assigns shall be liable for all costs incidental to the repair of such broken or damaged utility; and further Provided, That if it becomes necessary

to remove the paved street and alley return(s) at their entrance(s) (into E. Ferry, Harper and/or St. Aubin Avenues), such removal and construction of new curb and sidewalk shall be done under city permit inspection according to City Engineering Division — DPW specifications with all costs borne by "Barrick Cold Storage" and/or "Schlafer Iron & Steel", the abutting owner(s), their heirs or assigns; and further

Provided, That the City Clerk shall within 30 days record a certified copy of this resolution with the Wayne County Register of Deeds.

Petition No. 2811 of "McDonald's Corporation" requests the (outright) vacation of a westerly part of the east-west public alley, 20 feet wide, in the block bounded by Ashton Avenue, Southfield Freeway, Van Buren Avenue and Joy

The request was approved by Solid Waste Division — DPW and Traffic Engineering Division — DPW. The petition was referred to the City Engineering Division-DPW for investigation (utility review) and report. This is our report:

Michigan Department of Transportation (M-DOT) reported no objections to the public alley vacation near a M-DOT pump house at the Southfield Freeway.

Ameritech/Michigan Bell Telephone Company, Comcast Cablevision, Detroit Edison Company, and the Public Lighting Department reported overhead facilities in the public alley. Satisfactory arrangements (to relocate poles and overhead wires from the western part of public alley) are complete. Also, "McDonald's" must submit building plans to Water and Sewerage Department (DWSD) for review and approval of DWSD facility adjust-

"McDonald's" has paid the following city reimbursement costs:

Public Lighting Department [PLD]-Accounting:

\$5,000.00 — Treasurer Deposit No. 403352;

The estimated cost to remove and reroute the PLD poles and guy wire(s) is \$5,000.00.

All other city departments and privately owned utility companies have reported no objections to the requested. (outright) vacation. Provisions to protect the remaining public sewer are part of the vacating resolution.

plans 'McDonald's" development include the use of one paved public alley return into the Southfield Freeway service drive. "McDonald's" will pay all expenses to remove the paved public alley return (into Ashton Avenue) whenever discontinuance of use makes removal necessary; subject to city specifications, permits and inspection.
