Re: Petition No. 1237 — Part One (of two parts) City of Detroit Downtown Development Authority Land Assemblage Program. Rescind [demolished Hudson's building] Encroachments and Remaining Public Alley to Vacation block bounded by Woodward, Farmer, Gratiot and Grand River.

The City Council of the City of Detroit ("Council") approved the use of City of Detroit Downtown Development Authority ("DDA") Land Assemblage funds to acquire, remediate, demolish and prepare the Hudson Building site (the "Site") for redevelopment (the "Project"). The Site currently under the ownership of the DDA, retains a public alley within its boundaries, and eight encroachments for the former Hudson Building recorded in City of Detroit ("City") records.

To finalize the preparation of the Site for redevelopment it is necessary to vacate the public alley and to rescind the eight encroachments recorded in City records. Therefore, it is necessary to obtain approval from Council for Petition No. 1237,

Whereas, The Hudson building has been demolished and the Site prepared for redevelopment, however city records contain eight non-transferable encroachments into the public rights-of-way. The Site encroachment grants begin 1914 through 1966, and the eight grants do not have expiration dates. Unless they are removed from city records, encroachments can entangle the orderly transfer of property; therefore be it

The City Council of the City of Detroit "Council") approved the use of City of Detroit Downtown Development Authority ("DDA") Land Assemblage funds to acquire, remediate, demolish and prepare the Hudson Building site (the "Site") for redevelopment (the "Project"). The Site, currently under the ownership of the DDA, retains the existing basement walls. These walls, which cannot be removed, extend into the public street rights-of-way.

To finalize the preparation of the Site for redevelopment it is necessary to create four easements, one in each public street right-of-way bordering the Site, to allow extensions into the public street rights-ofway for the existing basement walls and any future underground basement areas extending from the lot lines of the property of the Site to these basement walls.
