Petition No. 3713 of Riverfront Holdings, Incorporated, a Michigan Corporation, whose address is 200 Renaissance Center, Suite 1300, Detroit, Michigan 48243 request the outright vacation of Atwater Street, 50 feet wide, between Rivard Street and St. Antoine Street and Schweizer Place (variable width) between Franklin Street and Atwater Street.

develop properties in "Renaissance Center Project" it is necessary to obtain Council approval for numerous adjustments in public rights-of-way (including vacations and dedications) within this area of the GM Global Headquarters and River East District. This phase will address the vacation of Atwater Street & Schweizer Place and a future phase will include the dedication of New Atwater Street between Rivard Street and St. Antoine Street, to be located just south of existing Atwater St., and being realigned with the Atwater St. construction taking place between St. Antoine and Bates south of the Renaissance Center.

This petition was referred to the City Engineering Division — DPW for investigation (utility clearances) and report. This

is our report.

The Public Lighting Department (P.L.D.) submitted a cost estimate in the amount of \$10,000.00 to accommodate the requested outright vacation of Atwater Street between St. Antoine and Rivard. This based on the assumption that Rivard Street will be rebuilt at a later date with new underground fed street lights. The removal and relocation of street lighting facilities is the responsibility of the project.

P.L.D. will require conduit construction new Atwater; estimated cost is \$250,000.00. Satisfactory arrangements have been made between the petitioner

and the P.L.D.

The Detroit Water and Sewerage Department (DWSD) has a 10-inch water main located in the portion of Atwater between St. Antoine and Rivard which is requested to be outright vacated. There is also a 3'-8" x 5'-6" sewer and a 8-inch water main located in Schweizer Place that cross Atwater Street, which is proposed to be relocated. DWSD has no objections to the proposed right-of-way changes provided that the existing 10inch water main in Atwater is cut and capped at St. Antoine and Rivard and the existing 8-inch water main in Schweizer Place is cut and capped at Atwater. In addition, the existing water mains in Atwater and Schweizer and the existing sewer in Schweizer are to be located in accordance with the attached resolution.

Also, the Petitioner has to give DWSD temporary easements for the existing water mains and existing sewers in Atwater and in Schweizer Place until these facilities are relocated. The cutting and capping of water mains and relocation of water mains and sewers are to be done in accordance with plans approved by DWSD and are to be done under DWSD's permit and inspection at

Petitioner's expense.

The above alterations to DWSD's water and sewer system are necessary to the right-of-way changes approve requested in the subject petition and do not include any water and sewer alterations which may be necessary for any proposed development in the area.

The Detroit Edison Company (DeCo.) reports no objection to the outright vacation of Atwater Street, however, a easement must be retained to service customers in a part of Schweizer Place requested to be outright vacated.

The petitioner has made arrangements with DeCo. of the exact location of the

easement, which will be temporary until the relocation is necessary to facilitate future Development.

The Detroit Fire Department (DFD) has requested that access be maintained for fire fighting purposes and that new Hydrants be installed to DFD specifica-

All other involved City departments and privately owned utility companies reported that they have no objections to the requested outright vacation(s) or that they have reached satisfactory agreements with the petitioner regarding their installation therein.
