WHEREAS, pursuant to petition and in accordance with the provisions of Section 18, Chapter IV, Act No. 283 of the Public Acts 1909, as amended, the Wayne County Department of Public Services has determined that all the occupants and adjoining owners have signed a petition to vacate property herein described; and

WHEREAS, pursuant to said petition, the County Executive has determined that it is advisable to absolutely abandon and discontinue:

Vacating all that portion of Greenfield Avenue (variable width), 20.00 feet West of the West line of Lots 18 and 19, and Lots 20 thru 27, inclusive as platted in Keibler's Schoolcraft Subdivision located in the City of Detroit, Wayne County, Michigan, as recorded in Liber 60, Page 26, Wayne County Records, Section 19, Town 1 South, Range 11 East, as bounded by the following four courses more particularly described as: Beginning at the Northwest corner of said Lot 18; thence S88°02'33"W 20.00 feet; thence S01°18'12"E 209.00 feet; thence N88°02'33"E 20.00 feet to the Southwest corner of said Lot 27; thence N01°18'12"W 209.00 feet along the West line of said Lots as platted to the Point of Beginning. Containing 4180 sq. ft./0.096 Acres of land, more or less; and

WHEREAS, the premises were reviewed in accordance with said statute;

Now therefore be it

RESOLVED, that the Wayne County Commission this 21st day of July, 2005 declares it is in the best interest of the public that the above described County road be absolutely abandoned and discontinued, and that said road is hereby absolutely abandoned and discontinued with reservation of an easement therein for existing public utilities and sewer purposes.
