Re: Petition #2152 request of U.A.W. to renew for five years the temporary alley closure at 940-996 Fischer within Lot 7-16 Bernbart and Fischer subdivision from June 30, 1988.

Investigation disclosed that the grant for the temporary closing of the above described alley has expired and the petitioner now wishes an extension of time. There have been no complaints since this alley closing has been in effect and no change in the conditions.


