Honorable City Council:

Re: Petition No. 1590, Nelson Iron Works, et al, Temporary Street Closing, Benham between Mt. Elliott and Ackley.

Petition No. 1590 of Nelson Iron Works, et al requests the temporary closing of Benham Avenue, 50 feet wide, between Mt. Elliot and Ackley Avenues.

The request was approved by the Community and Economic Development Department with certain restrictions.

The Water and Sewerage Department will require unimpeded access to an existing water main. Any fence and gate installation must provide 13 feet horizontal and 13 feet vertical clearance(s) for maintenance vehicles.

All other City departments and privately owned utility companies have reported no objections to the proposal, provided they have the right to ingress and egress at all times to their facilities.

An appropriate resolution containing the necessary conditions is attached for consideration by your Honorable Body.

Resolved, The City Engineering Department is hereby authorized and directed to issue permits to "Nelson Iron Works, et al" to close Benham Avenue, 50 feet wide, lying between and abutting the east line of Mt. Elliott Avenue (56 feet wide) and the west line of Ackley Avenue (50 feet wide), described as: lying southerly of and abutting the south line of Block 1, of "Benham Manufacturing Company's Subdivision" of lots 1, 2, 3, 4 and 5 and vacated alley of H. L. Baker's Subdivision of lots 16, 17, 18, 19 and West Half of 20 of the Subdivision of the North Half Section 28 and the Northeast Fraction of Section 29, Town 1 South, Range 12 East, Hamtramck Township, City of Detroit, Wayne County, Michigan as recorded in Liber 28, Page 81, Plats, Wayne County Records; also lying southerly of and abutting the south line of the west 10.00 feet of Lot 19, and Lots 6 to 18 of "H. L. Baker's Subdivision" of Lots 16, 17, 18, 19 and the West Half of 20 of the Subdivision of the North Half of Section 28 and the Northeast Fraction of Section 29, Town 1 South, Range 12 East, Hamtramck Township, City of Detroit, Wayne County, Michigan as recorded in Liber 9, Page 55, Plats, Wayne County Records; also lying northerly of and abutting the north line of Lots 61 to 76, the previously vacated (December 23, 1952 - J.C.C. page 2817) north-south public alley (20 feet wide), and Lot 77 as plat- ted in said "H. L. Baker's Subdivision", City of Detroit, Wayne County, Michigan as recorded in Liber 9, Page 55, Plats, Wayne County Records; on a temporary basis to expire on May 1, 1993;

Provided, The petitioner shall file with the Finance Department an indemnity agreement in form approved by the Law Department. The agreement shall save and protect the City of Detroit harmless from all claims, damages or expenses that may arise by reason of the issuance of permits and the faithful perfor-

mance by the petitioner of the terms thereof. Further, the petitioner shall agree to pay all claims, damages or expenses that may arise out of the maintenance of the temporary public street closing; and

Provided, The permit shall be issued after the petitioner has recorded a certified copy of this resolution with the Wayne County Register of Deeds. The petitioner shall pay all incidental recording costs; and

Provided, The property owned by the petitioner and adjoining the temporary public street closing shall be subject to the proper zoning or regulated use (Board of Zoning Appeals Grant) over the total width and length of the street; and

Provided, No building or other structure (except necessary line fence) shall be constructed on or over the street. The petitioner shall observe the rules and regulations of the City Engineering Department. The City of Detroit retains all rights and interests in the temporarily closed public street. The City and all utility companies retain their rights to service, inspect, maintain, repair, install, remove or replace utilities in the temporarily closed public street. Further, the petitioner shall comply with all specific conditions imposed to insure unimpeded 24-hour-per-day access to the City and utility companies; and

Provided, That at the expiration of the permit, all obstructions shall be removed at the petitioner's expense. The public property shall be restored to a condition satisfactory to the City Engineering Department by the petitioner at the petitioner's expense; and

Provided, The petitioner's fence and gate installation shall provide 13 feet horizontal and 13 feet vertical clearance(s) for utility maintenance vehicles; and

Provided, This resolution is revocable at the will, whim or caprice of the City Council without cause. The petitioner waives the right to claim damages or compensation for removal of encroachments. Further, the permittee acquires no implied or other privileges hereunder not expressly stated herein. If this permit is continued for the five (5) year period, the City Council may (upon written request and if the circumstances justify accordingly) grant an extension thereto; and

Provided, This permit shall not be assigned or transferred without the written approval of the City Council.

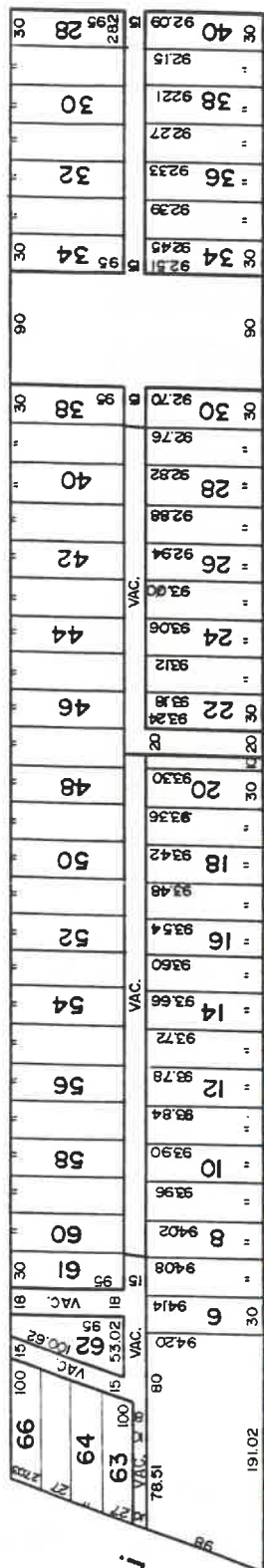

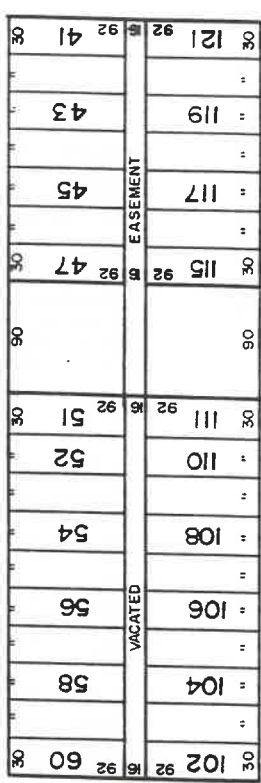
