By Council Member Cleveland:

Whereas, On May 18, 1988 (J.C.C. pp. 1239-40) the City Council approved the petition of Ronald D. Muir, et al, (1414) to allow for the closing of Cornwall Avenue between University Place and Marseilles Avenue on a temporary basis to expire on June 1, 1993; and

Whereas, There was no public hearings held by the administrative departments nor the City Council prior to the approval of this street closing; and

Whereas, City Council received a complaint from Jean Furay of the Organized Neighbors East Community Organization regarding the installation of a fence across Cornwall at the point where the street closing was approved; and

Whereas, At a discussion by the City Council on September 29, 1989 several residents of the area stated that the fence across Cornwall created traffic problems and hindered access to the area by emergency vehicles and a petition in opposition to the street closing signed by over 300 area residents was presented; and

Whereas, Upon obtaining input from the discussion, the City Council feels it is in the best interest of this community for Cornwall between University and Marseilles to be reopened;

Now, Therefore, Be It Resolved, That the City Council hereby rescinds its resolution of May 18, 1988 which allowed for the closing of Cornwall Avenue between University Place and Marseilles.
