After careful consideration of all the factors involved, it is the recommendation of the Community and Economic Development Department that the temporary closing of the alley, as shown on Plan #A 3540 be extended for an additional five (5) year period subject to all the provisions as they apply to the extension of a temporary closing.

Resolved, That the Department of City Engineering be and is hereby authorized and directed to Issue permit to New Jerusalem Church of God, owner of the property adjoining the alley herein concerned, to extend the closing of 20 feet wide alley @ west of Linwood @ West Grand Blvd. n/s on temporary basis for a period not exceeding five (5) years from June 30, 1990 in accordance with the Community and Economic Development Department Plan No. A3540.

Provided, That Petitioner shall be subject to any tax which may be levied against it pursuant to law with regards to such use of public property; and further Provided, Petitioner first furnished an

agreement, in form approved by the Law Department, saving and protecting the City of Detroit harmless from any and all claims, damages or expenses that may arise by reason of the issuance of said permit, and providing for the faithful per-formance by the grantee of the terms hereof, and files same with the Finance Department; and further

Provided, That said permit shall be issued only after a certified copy of this resolution has been duly recorded in the office of the Wayne County Register of Deeds, by and at the permittee's expense; and further

Provided, That no building or other structure is constructed in said alley; that Petitioner shall observe the rules and regulations of the Department of City Engineering, and further subject to the following provisions:

The City of Detroit retains all rights and interests in the area herein temporarily closed:

The City and all utility companies retain their rights to establish, maintain and service any utilities in said area of temporarily closed alley; and further

Provided, That at the expiration of said permit, all obstructions therein shall be removed at the expense of the grantee, and the public property affected shall be restored to a condition satisfactory to the Department of Public Works and at the permittee's expense; and further

Provided, That grantee acquires no implied nor other privileges hereunder not expressly stated herein; and further

Provided, This resolution is revocable at the will, whim or caprice of the City
