Dear City Clerk:

This letter is submitted as our Petition as the 100 percent owner of real property immediately abutting and adjoining the public alley right of way set forth in the attached survey diagram dated September 20, 1994. The subject alley is more particularly identified as being 292.12 feet east-west, by 15 feet north-south running east from Rivard to Lot 20 of Plat of part of Louis Moran, Sr. Farm, City of Detroit, Wayne County, Michigan as recorded in L. 8, P. 173-174, WCR.

Woodbridge Investment Company is the legal titled owner of all the real property immediately abutting and adjoining the southern line of the alley that being Lots 31-36 inclusive, Plat of part of Rivard Farm, south of Jefferson Avenue as subdivided for H. M. Campbell and T. Clark, Proprietors, L. 6, P. 51-52, WCR.

Additionally, Woodbridge Investment Company is the equitable owner (legal title being held by the Economic Development Corporation of the City of Detroit pursuant to a certain mortgage and trust indenture and a lease purchase agreement dated July 1, 1984) of the real property that immediately abuts and adjoins 206.50 feet of the north line of said alley commencing at Rivard Street running directly west, which property is more fully described as Lots 20-24 inclusive and the east 11.5 feet of Lot 19 of Plat of part of Rivard Farm, south of Jefferson Avenue as subdivided for H. M. Campbell and T. Clark, Proprietors, L. 6, P. 51-52, WCR.

As equitable and legal owner of said property and as sole possessor and user of said real properties, we respectfully request the formal vacating and abandonment by the City of Detroit to Woodbridge Investment Company of this former public alley right of way. The referred public alley has not been used as an alley access for more than



RE: Petition No. 1714 - Woodbridge Investment Company. Requested outright alley vacation, in the block bounded by Schweitzer, Franklin, Woodbridge and Rivard

Petition No. 1714 request the outright vacation of the east-west public alley, 15 ft. wd., in the block bounded by Schweitzer Place, Rivard St., Franklin St., and Woodbridge St..

The petition was referred to the City Engineering Division-DPW for investigation (utility review) and report. This is our report.

The Detroit Water and Sewerage Department (DWSD) has an existing 15"x20" sewer in the east-west alley bounded by Schweitzer Place, Woodbridge, Rivard and Franklin. DWSD has no objection to the requested outright vacation of the public alley if petitioner owns the abutting lots 31-36 and lots 19-24.

The Traffic Engineering Division-DPW have no objection to the outright vacation of the east-west alley in the block bounded by Schweitzer Place, Rivard, Franklin and Woodbridge provided 100% of the abutting property owners' signatures are obtained.

On March 20, 1998, the Woodbridge Investment Company provided, the Consent and Waiver of Objection signed by the Senior Warden at Christ Church of Detroit.

City departments and privately owned utility companies reported no objection to said outright vacation.

I am recommeding adoption of the attached resolution.

Provided, that the City Clerk shall within 30 days record a certified copy of this resolution with the Wayne County Register of Deeds.
