I am writing to petition City Counsel for permission to put up a patio service area in front of my bar.

The bar (Village Pub East) is located on the east side at 17501 Mack Avenue in Detroit. I have had the Liquor Control Commission out to investigate and approve the area in question. The approximate dimensions are 13'x35'x7' in front of the business. This area includes part of the city sidewalk, but still leaves approximately 7' of side walk to walk around the patio area. I am planning to put up a temporary 4' tall fence type barricade for the months of June through September. The rest of the year the barricade will be taken down and the patio will not be in use.

My business is struggling like many other small businesses in Detroit, in fact I'm currently in a Chapter 11 Bankruptcy. I hope to get approval on this patio service area, not only as a boost to business but also as part of my business plan to reorganize under Chapter 11 Bankruptcy.

I would appreciate and special attention you could give this matter to help expedite the situation.
