City Council approved "Phase One" of Pelition No. 3681 of "Detroit/Wayne County Stadium Authority" on April 23, 1998. The previously approved resolution vacated certain public streets, alleys and utility easements in the area bounded by Woodward Avenue, Brush Street, Adams Avenue, and the Fisher Freeway Service Drive; vicinity of the new "Tigers" stadium site, including related planning/construction activities.

"Phase Two" of Petition No. 3681 of "Detroit/Wayne County Stadium Authority" requests the following modifications of city rights-of-way; vicinity of the new "Lions" stadium site:

 Outright vacation of certain public streets, alleys, and utility easements within three "Lions Stadium" site development parcels; and

(2) Establish the eventual public street right-of-way of "Relocated" Montcalm-St. Antoine Street (60 feet wide, and variable width curved roadway); and

(3) Deline by legal description(s) parcels to be acquired from the Michigan Department of Transportation for 'Relocated' Montcalm-St. Antoine Street; Brush Street, (proposed) Montcalm-St. Itoine Street, and Adams Avenue, in heral, bound the new Lions stadium tprint".

City Council approved amendments (November 13, 1996 — J.C.C. page 2497; also April 11, 1997 — J.C.C. pages 785-86) to a lax increment financing plan and development plan for Area No. 1' to allow for the construction of the new Tigers and Lions stadia. City activities, within development agreements, includes various adjustments to public rights-of-way to accomplish the Tigers/Lions Stadia Complex Project.

The petition was referred to the City Engineering Division — DPW for investigation (utility clearances) and report. This is our report:

Traffic Engineering Division — DPW approved the public street closing(s); and the alignment of proposed "Relocated" Montcalm-St. Antoine Street (60 feet wide, and variable width curved roadway).

After State owned parcels are acquired from Michigan Department of Transportation, City Council is requested to accept them for the "Relocated" Montcalm-St. Antoine Street (60 feet wide, and variable width curved roadway).

Since, the outright vacations are the result of necessary public improvements, all private utility companies are required to relocate their facilities from the vacated streets, alleys, and utility easements. Planning and Development Department (working together with the "Downtown Development Authority", and "City/Wayne County Stadium Authority") must consult with the Law Department to determine which utility removal and/or relocation costs incidental to the Tigers/Lions Stadia Complex Project are properly payable under current law.

I am recommending adoption of the attached resolution.


