Honorable Council Members,

On behalf of the Mercy Hospital Clinic, D/A Central, Inc., (prime contractor) and Corby Energy Services, Inc. (sub-contractor), we hereby request that you approve a petition from the Mercy Hospital Clinic for a right-of-way encroachment under Springle Street. The proposed facilities are shown on the attached sketch and are described as follows:

- 1. Purpose: To provide electric power and control wiring to operate security gates in the parking lot located at the southwest corner of E. Warren and Springle.
- 2. Encroachment Description: To install two 1 1/4" HDPE conduits under Springle Street from the west wall of the clinic building on the southeast corner of E. Warren and Springle, to the parking lot on the west side of Springle. The conduits will carry electric power wiring (240V) and copper control wiring from the interior of the clinic building to gate controls and operators located in the parking lot. The depth of the conduits are proposed to be 36" to 48" under the Springle Street pavement surface.
- 3. Work Schedule: Work is scheduled to begin immediately after the encroachment is approved.
