I have recently purchased an industrial building located at 20445 Glendale, Detroit 48223. There is an unpaved dead end street, Fielding St, extending along the west side of the building for 200 ft and ending at the rear property line. There are two other industrial property owners adjacent to this 200 ft x 50 ft wide section of Fielding St. All of the property owners agree that it would be in the best interest of everyone if this portion of Fielding was vacated by the city and put on the tax rolls. I intend to improve this 200 ft section of dirt road so that it can be used as an access driveway by the adjacent property owners and eliminate it as a neighborhood eyesore and breeding ground for mosquitoes.
