

Petition No. 3438 - "Callewaert Marketing Services", requesting for the outright RE: vacation of the commercial alley in the area of Gratiot Avenue, Peter Hunt Avenue, and Bessemore Avenue.

Petition No. 3438 of "Callewaert Marketing Services", at 21711 West Ten Mile Road, Suite 200, Southfield, Michigan 48075, for Alexander and Homung Food Products, request for the outright vacation of the Southerly portion of the North - South public alley, 16 feet wide, in the block bounded by Gratiot Avenue, 120 feet wide, Vinton Avenue, 60 feet wide, Bessemore Avenue, 50 feet wide, and Petet Hunt Avenue, 50 feet wide, for the construction of a new addition to their existing building founded in the year 1945.

The request was approved by the Planning and Development Department, the Solid Waste Division - DPW, and the Traffic Engineering Division - DPW. The petition was referred to the City Engineering Division - DPW for investigation (utility clearance) and report. This is our report.

The Detroit Water and Sewerage Department (DWSD) reported there is an existing sewer in said alley that must remain in service unless the petitioner owns all of the property served by the sewer. Otherwise DWSD can agree to the requested outright vacation only if DWSD is granted an easement for their facilities.

DTE Energy Gas and Electric reported there is an existing 4-inch Cast Iron gas main in the said alley, and can prepare a cost for the removal and /or rerouting of gas services; Also DTE reported a cost of \$30,500.00 for the removal and/or rerouting of electric services.

All other city departments and private utility companies have reported no objections to the requested outright vacation

I am recommending adoption of the attached resolution.


