Please consider our request for the conversion of alleyway to easement. This request will affect three occupied properties, 9100/9102, 9116 Quincy, and 4060 Clairmount, in the city of Detroit. The property at 4060 Clairmount is the only one that would be directly affected by this request because its access to its garage is through that space. Over the years the problems resulting in public uses of this space has increased. From loitering, constant walking at all hours of the day and night, to even persons engaging in sexual activities. For these reasons we feel it is time that this space be closed and secured.

With the granting of this alley closure, we are sure that the unnecessary problems will be eliminated. Ever with this action by you, we still have a greater concern, and that would be the abandoned and open properties around us, which are located on both Quincy and Joy Road. The property on Joy Road is directly behind the Clairmount addresses (from 4020 to 4060 Clairmount). This area is open and poses a danger to my fellow neighbors and myself. Thrash has been dumped, vehicles burned, sex acts performed and even a homicide have been committed (4033-4055 Joy Road and 9130/9132 Quincy).

In closing, we respectfully plead with you to consider our request for security and peace with your permission to close this area. And with your help we can begin to move forward in our quest for a safe and clean neighborhood and do our part in improving this great city we call home-Detroit, Michigan.
