This office represents The Salvation Army – DHQ. The Salvation Army is currently in the process of purchasing 4864 17th Street, 2456 W. Hancock Street, 4883 Grand River Avenue and 2456 W. Hancock Street as the future site of its homeless shelter. These properties are zoned as M4. Our client has submitted an Application for Rezoning to the City Planning Commission to change the zoning to R6.

The Salvation Army plans to (a) tear down the current structures on these 4 properties and (b) build a brand new structure (see the sketches attached hereto as Exhibit A). There is a public alley that runs northwest from Hancock Avenue toward Warren Avenue, between the properties located at 4864 17th Street and 2456 W. Hancock Street. 




