

down. All cars have no respect for this intersection at Westbrook and Karl.

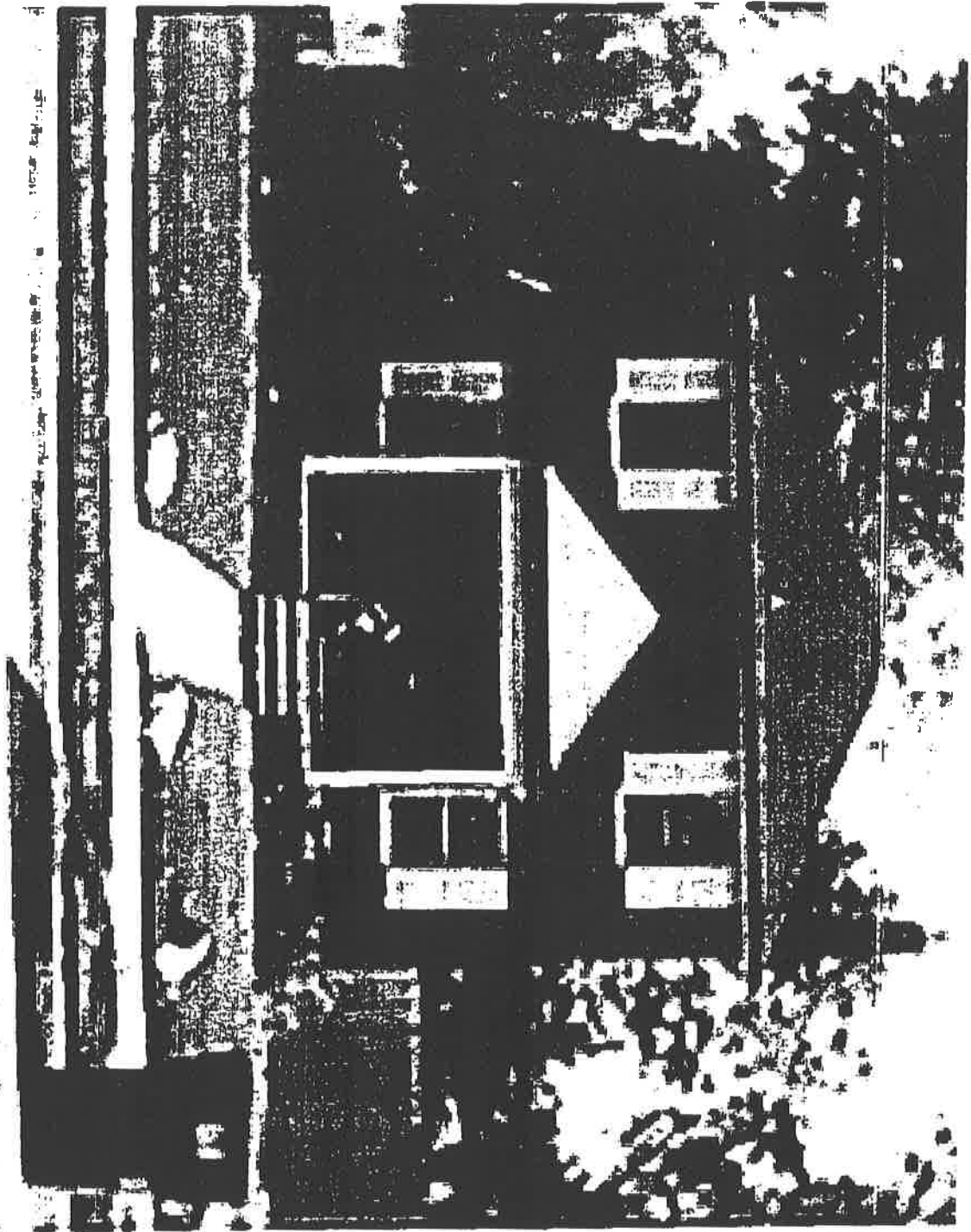
