I so enjoyed talking to you. Below is my email and phone number.

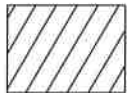
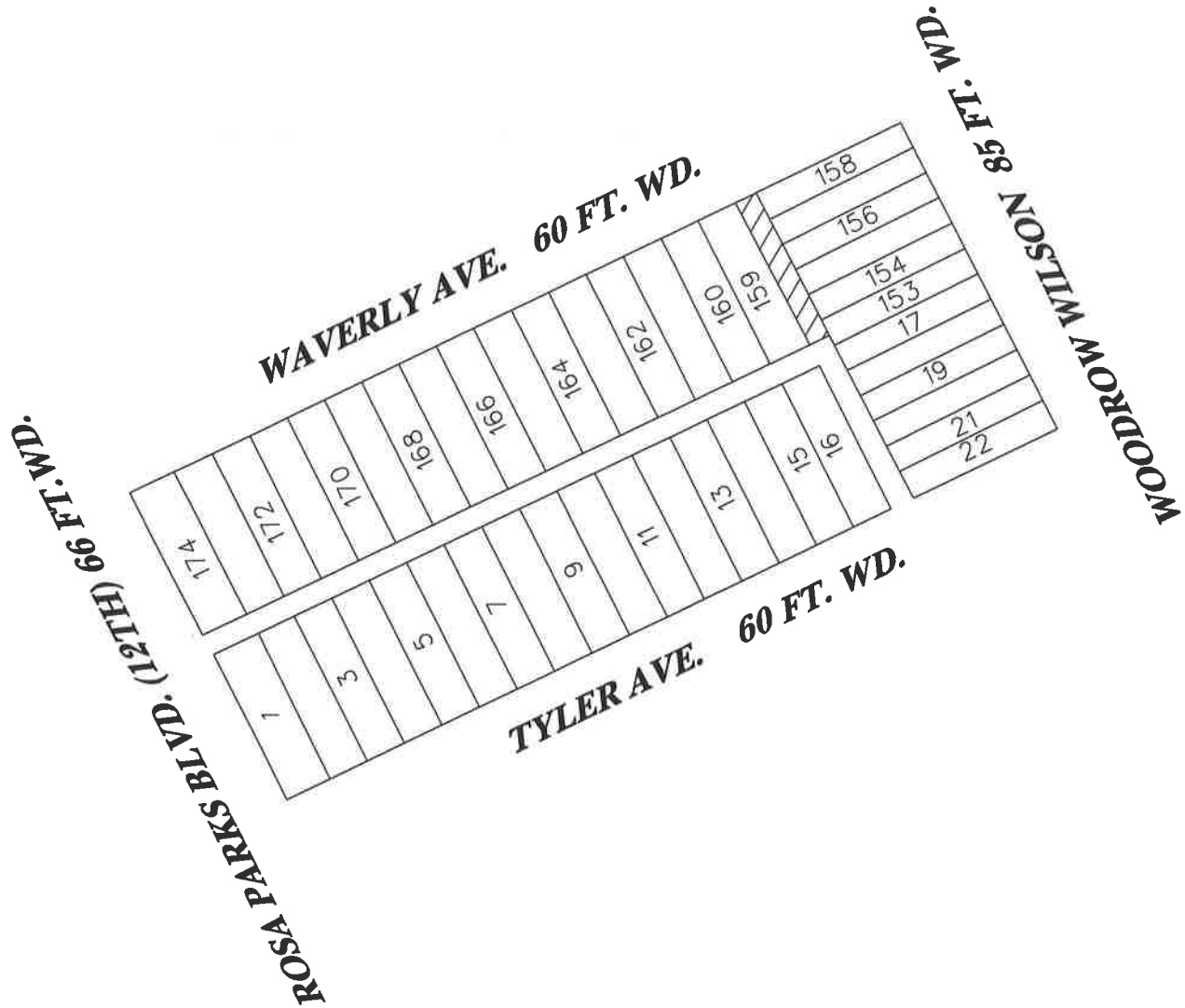
Here is what we are asking:
