I am writing to request vacation (outright) of a easement located within the vacated alley lying west of and parallel to Cass Avenue extending from the north line of Burroughs Avenue and south of the south line of Amsterdam Street, between lots 1 and 8 both inclusive and lot 11, block 12 Cass Farm Co. Ltd., subdivision of part of Cass Farm.

The vacation will provide the opportunity for renovation an obsolete three story parking structure.

Copy of the request submitted to DWSD to reroute a portion of the sewer that runs north/south in the alley immediately east of the building at 435 Amsterdam.


