Trumbull, Brooklyn, Perry and Temple

On April 07, 2006 City Council approved Petition No. 4118 of Detroit Entertainment, L.L.C. ("MotorCity Casino—Expansion Site"). That approved petition requested one street and four alleys to vacation, a public access easement to vacation, two overhead walkways and a vehicular bridge crossing city rights-of-way, and easements for building façade projections in the area bounded by Trumbull, Elm, Grand River, Lodge Expressway and Spruce.

On December 11, 2006 City Council approved Petition No. 4118—(*first*) Addendum of Detroit Entertainment, L.L.C. ("MotorCity Casino—New Continental Building). That approved petition requested under ground footings for the MotorCity Casino—New Continental Building. The footings extend into the eastern margin of Brooklyn Avenue, the western margin of John C. Lodge Expressway Service Drive, and two public alleys (vacated, but reserving DWSD sewer provisions).

A parking structure at the MotorCity Hotel Tower is under construction. Generally, the "Hotel Tower" block is bounded by Trumbull and Brooklyn Avenues, Perry Street and Temple Avenue. City Engineering Division—DPW received design drawings showing under ground footings and above ground pilaster-columns for the "MotorCity Casino New Parking Garage at Hotel Tower." The footings will extend into the southern margin of Temple Avenue, the northern margin of Perry Street, and the eastern part of a north-south public alley (in the "Hotel Tower" block). Therefore, said Petition No. 4118, requires a (*second*) addendum to include under ground and above ground "easement(s) for permissible *BUILDING STREET-ALLEY PROJECTION* purposes."

The resolution delineates by land description (relationship to property lines) the horizontal position of each under ground footing and above ground pilaster-column, which will extend into streets and alley rights-of-way. Vertically, the 22 footings and 18 pilaster-columns are positioned under ground level (Detroit City datum, generally below **129.75** more or less) and above ground level (Detroit City datum, generally above **129.75** more or less).

Buildings and Safety Engineering Department and the Water and Sewerage Department remain involved in the ongoing review of MotorCity Casino plans for building permits. MotorCity Casino will restore the public alley surface and public sidewalk margins at no expense to the City under City Engineering Division—DPW specifications and permits.

Whereas, On April 07, 2006 City Council approved Petition No. 4118 of Detroit Entertainment, L.L.C. ("MotorCity Casino—Expansion Site"). That approved petition requested one street and four alleys to vacation, a public access easement to vacation, two overhead walkways and a vehicular bridge crossing city rights-of-way, and easements for building façade projections in the area bounded by Trumbull, Elm, Grand River, Lodge Expressway and Spruce; and

Whereas, On December 11, 2006 City Council approved Petition No. 4118—(*first*) addendum of Detroit Entertainment, L.L.C. ("MotorCity Casino—New Continental Building). That approved petition requested under ground footings for the MotorCity Casino—New Continental Building. The footings extend into the eastern margin of Brooklyn Avenue, the western margin of John C. Lodge Expressway Service Drive, and two public alleys (vacated, but reserving DWSD sewer provisions); and

Whereas, The April 07, 2006 approved Petition No. 4118 resolution listed easement sections as follows:

MotorCity Casino Building

[Section A] ground level, and [Section B] above ground level; also

MotorCity Continental Building

[Section C] ground level, and [Section D] above ground level; and

Whereas, The December 11, 2006 approved Petition No. 4118 (*first*) addendum resolution listed an easement section as follows:

MotorCity—New Continental Building

[Section E] under ground footings; and

Whereas, A parking structure at the MotorCity Hotel Tower is under construction. Generally, the "Hotel Tower" block is bounded by Trumbull and Brooklyn Avenues, Perry Street and Temple Avenue. City Engineering Division—DPW received design drawings showing under ground footings and above ground pilaster-columns for the "MotorCity Casino New Parking Garage at Hotel Tower." The footings will extend into the southern margin of Temple Avenue, the northern margin of Perry Street, and the eastern part of a north-south public alley (in the "Hotel Tower" block). Therefore, said Petition No. 4118, requires a (*second*) addendum to include under ground and above ground "easement(s) for permissible BUILDING STREET-ALLEY PROJECTION purposes." The requested easements are identified in this resolution as follows:

MotorCity Casino New Garage at Hotel Tower—Footings

[Section F] under ground footings; also

MotorCity Casino New Garage at Hotel Tower—Pilaster/Columns

[Section G] above ground pilaster-columns;

Whereas, Buildings and Safety Engineering Department and the Water and Sewerage Department shall remain involved in the ongoing review of MotorCity Casino plans for building permits. MotorCity Casino shall restore the public alley surface and public sidewalk margins at no expense to the City under City Engineering Division—DPW specifications and permits (Detroit Code Section 50, Article 4); therefore be it

RESOLVED, To expand, construct and maintain the "MotorCity Casino New Garage at Hotel Tower" it is necessary to grant "easements" for parts of the garage structure (22) underground footings and (18) above ground pilaster-columns that will extend into the public street(s) and alley rights-of-way. The easement sections are listed as follows:

MotorCity Casino New Garage at Hotel Tower—Footings
[Section F] under ground footings; also

MotorCity Casino New Garage at Hotel Tower—Pilaster/Columns
[Section G] above ground pilaster-columns;

NOTES: In "Sections F and G" of this resolution "easement(s) for permissible **BUILDING STREET-ALLEY PROJECTION** purposes" means a non-possessing interest—delimited elevations in city datum [under ground level (Detroit City datum, generally below 129.75 more or less) and above ground level (Detroit City datum, generally above 129.75 more or less)]—within public lands, two streets and one alley rights-of-way, to expand, construct and maintain parts of the footings and pilaster-columns of the "MotorCity Casino New Garage at Hotel Tower". When this specific purpose is extinguished (meaning if the "MotorCity Casino New Garage at Hotel Tower" is razed by its land title holders) the public lands, street(s) and alley rights-of-way, revert back to their full height(s)-width(s)-depth(s) [defined by city records] free of "MotorCity Casino New Garage at Hotel Tower", burden(s) or easement(s).
