We sincerely hope that you will consider this request. Thank you in advance for your attention to this matter.

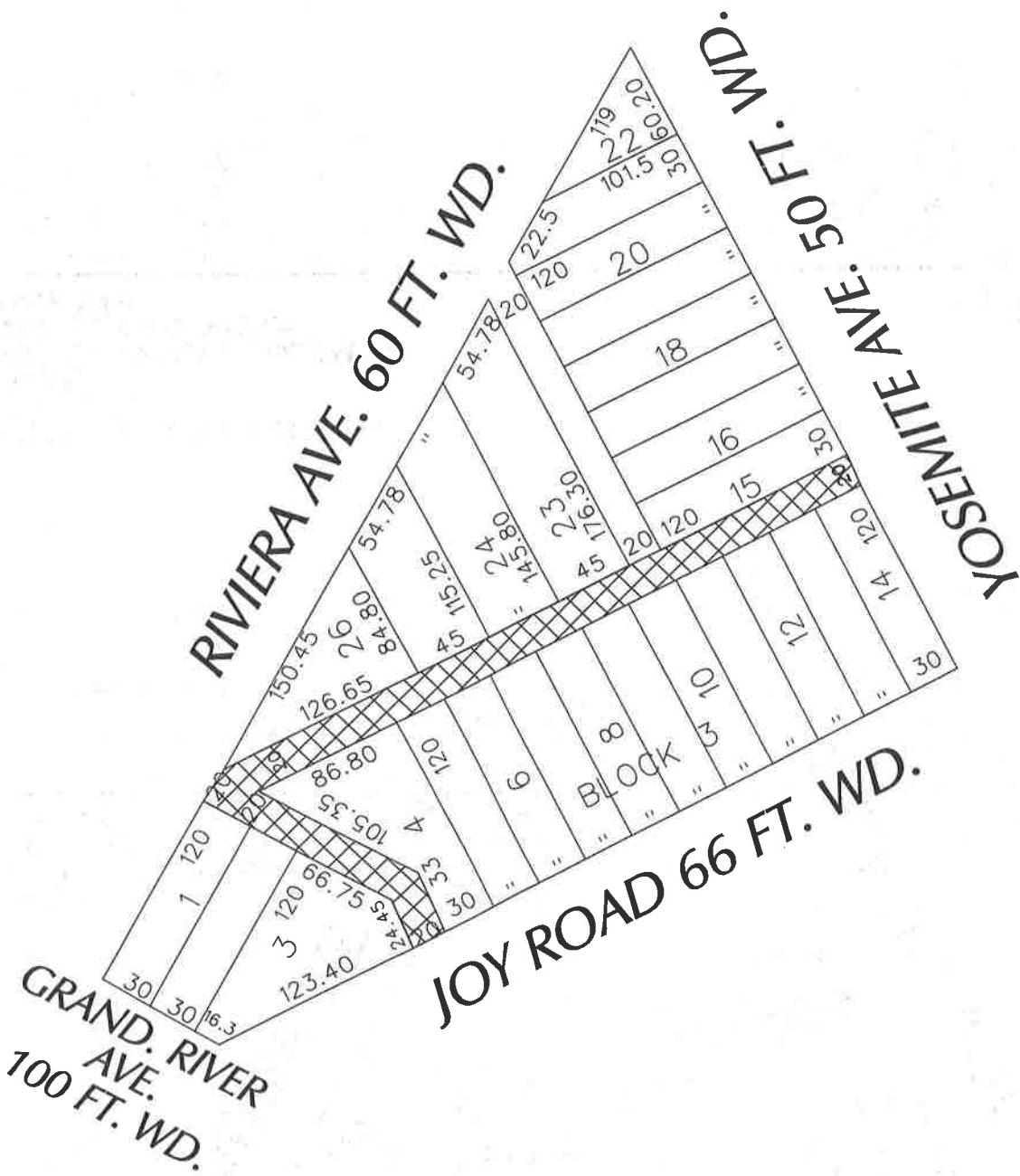
