



Peition No. 3887 – Midwest Capital Investment Amwick Housing, requesting right-of-way dedication of five streets lying between Mound, Buffalo, Charles and Talbot Avenues.

RE: Petition No. 3887 of "Midwest Capital Investment Amwick Housing" request the City Council to accept and/or approve the dedication of private land for new public streets and the naming of new streets with in the block bounded by Charles Street, 76 feet wide, Talbot Avenue, 60 feet wide, Buffalo Avenue, 70 feet wide, and Mound Road, 204 feet wide, all within the Emerald Spring Estates formerly know as the Charles Street Housing Project.
