



Petition # 5382: The Next Neighborhood Initiative (NDNI) is requesting authorization to display public art within six NDNI neighborhoods.

Traffic Engineering Division (TED) of Department of Public Works (DPW) has received and reviewed the above-mentioned petition regarding the display of public arts at various locations within six NDNI neighborhoods.

Traffic Engineering Division, DPW, has no objection to the requested display of public art provided that the following conditions are met with:

- (1) The request regarding East English Village cannot be approved by TED since Chandler Park drive falls under the jurisdiction of Wayne County Roads Commission (WCRC). Please seek permission from WCRC in this regard.
- (2) The request regarding Grand River and Greenfield cannot be approved by TED since Grand River falls under the jurisdiction of Michigan Department of Transportation (MDOT). Please seek permission from MDOT in this regard.
- (3) The petitioner is responsible to seek approval from all affected stakeholders.
- (4) The art display shall in no way obstruct visibility for pedestrian or vehicular traffic.
- (5) All art display shall have a minimum of 3ft. clearance from the curb line at all times.
- (6) All art display shall be mounted so that a minimum of 6 ft clear sidewalk is maintained at all times.
- (7) A minimum of 10ft, clear height/under clearance shall be maintained at the ground/sidewalk level.
- (8) All costs associated with this work shall be paid for by the developer.

TED requests the petitioner to submit site specific drawings of each art display taking into consideration the above-mentioned conditions. Upon receiving the drawings, TED will review and respond to each case.
